## 8. Ordinance No. 127-03 - Second Reading - Street & Alley

An ordinance authorizing the vacation of a portion of McKinley Avenue S.E., (0.238 acres) and 45 feet in width, a portion of Hartman Street S.E. (0.581 acres) located east of McKinley Avenue S.E. (to be vacated) and a portion of Alley No. 41 (0.015 acres) and 14 feet in width, located within the corporate limits of the City of North Canton.
