8. Ordinance No. 1-03 - Third Reading - Park & Recreation

An ordinance accepting City Out Lot No. 299 in the Washington Square Allotment, within the corporate limits of the City of North Canton, for public green space purposes.

9. Ordinance No. 9-03 - Third Reading - Water, Sewer & Rubbish

Ordinance No. 9-03 amending TITLE THREE - Utilities, CHAPTER 921, Sewer Code, Section 921.04 SEWER CONNECTIONS; PERMIT; FEE. of the Codified Ordinance of the City of North Canton by the addition of paragraph(d).

10. Ordinance No. 13-03 - First Reading - Street & Alley (TABLED 1/27/03)

An ordinance authorizing the Board of Control of the City of North Canton, through the Director of Administration, to advertise and receive bids according to specifications now on file in the office of the Director of Administration and the Mayor to enter into a contract for the installation of a traffic signal at the intersection of North Main Street and Wilbur Drive NE and declaring the same to be an emergency.
