Mr. Sarbach: Violin strings have gone up over the last few years.

Mayor Rice: Evidently.

Mr. Snyder: Well, they're union musicians. They're paid scale.

Mayor Rice: Yea, they're union musicians. So they do have some significant costs with that but like I said we have had some sponsors in the past. We're going to try to continue those sponsors and maybe hopefully pick that up and hopefully find some additional sponsors, additional money for it.

Mr. Sarbach: Maybe we can get the CIC to help sponsor that. You think?

Mayor Rice: We might be able to sell the Oster property. Just kidding. I'm just kidding.

Mr. Sarbach: Then we can buy the POPS. I agree it's a really worthwhile community project.

Mrs. Kiesling: Here we go.

Mayor Rice: Ok, the second item. To Council and especially to Councilman Snyder in the 4th Ward, I've gotten some inquiries from the residents up at Lands Down neighborhood with the pending project. There seems to be a lot of maybe conflicting information or uncertainty by many of the residents up there so they requested, they contacted and said they would like us to have a meeting. So just to let you know and the rest of Council. And we'll do it in cooperation in a joint release with those folks. What we want to do is coordinate a date and time to set up a meeting for those residents probably here at City Hall some evening. And I've already talked to Jim. What we do is get the Engineering Department here, as well as the firm that's doing that design. Which is who?

Mr. Benekos: Michael Benza and Associates.

Mayor Rice: Benza, ok. And so we'll try to coordinate a time that we're all available and they're available to bring those residents in or offer them the opportunity to come in. And so the engineers they can tell them that status of that and the timeline for that. Because there's a lot of, I think, misinformation going on out there. So at the request of the residents, I wanted to let you know and the rest of Council...

Mr. Snyder: I appreciate that.

Mayor Rice:we'll be in contact with you about selecting a date and putting out a joint letter to those people out there so we can inform them what's going on. Probably, we're looking at, according to Jim, to get the engineer here, probably three weeks out or something like that to give them time to fit in their schedule to come in here. Ok, so we'll keep you updated on that. Third thing just for Council and for the public, I think it's nice we've had two recognition awards come to our, two of our police officers. First was our DARE Officer, Mike Foltz. He's been chosen by the State of Ohio Elks Organization for their Robert Powell Drug Awareness Education Award, who's a recipient of the year. He was down in Columbus this past Saturday, yea past Saturday, to the Elks' State meeting to receive that award. So it's very nice, he was nominated by the North Canton Elks for the honor and Mike was very pleased, as we were, with his recognition for the great work he does with our DARE Program. Just reinforces, a lot of communities are cutting out their DARE Program. Unfortunately, when other communities cut it out people all think our DARE Program is going. And once again, we have no intention of losing our DARE Program. Mike does a great job and Chief Grimes does a wonderful job supporting that. So I think it's important to note that Officer Foltz got that award. Also, Frank Kemp, one of our other patrolmen was recognized by the North Canton Jaycees, I think it was about a week ago, with their Distinguished Service Award for his seven years of service here with the City. The Jaycees give that out every year. They look for deserving safety service, safety workers--police, fire, ems. Not just from North Canton but they can be from, I know they've recognized people I think from Greentown and Plain and that in the future. So he's one of our patrol officers and runs bike patrol and also does some firearms instruction. So Frank Kemp was also recognized. So it's nice to see our officer, two of our officers receive some real nice recognition here in the last week. I wanted to make sure everybody was aware of that. With that, that's all I got I believe.

further away so we're, we will actually have to physically go back and hook that in to the new, when we abandoned that and hook it in, which I think everybody is aware of, but I think that's what she's talking about. That's not technically part of this. This is strictly within the Sanctuary.

Mr. Snyder: Well the reason we're oversizing the line is to accommodate the Holl Road. If we don't oversize the line, we can not accommodate her hookup.

Mayor Rice: Right. And if we weren't going to abandon that like we say we're going to, there'd be no reason to upsize...

Mr. Snyder: That's what I'm saying. That's the reason we're doing that. To eliminate the other lift stations.

Mayor Rice: But just so everybody's aware, there will be additional costs to actually do that when everything else is done. We have to do that, not the developer.
