Mr. Snyder: Those oppose same sign. Motion carries 6-0. Is there anyone in the audience wishing to speak to the Council this evening? If so, step forward state your name and address for the record.

#### Recognition of Visitors

Mr. Osborne: My name is Chuck Osborne, 307 Fairview Street SE, North Canton, Ohio. Last week, on Monday, August 22, 2005 there was a public hearing before this council body. The purpose of the hearing was to consider a request by a developer for an amendment to the North Canton Zoning Ordinance requesting a zone change for property situated on the south side of Applegrove Street NW. The zone change is needed to accommodate the relocation of a new dental center for the City of North Canton. The dental center will house three dentists, six dental hygienists and seven or more dental assistants and clerical staff. My question to this council body, to City Administrator Michael Miller, and most importantly to Mayor Tom Rice is this, why isn't North Canton's newly hired Economic Development Director working to bring this professional facility to North Canton? Do we have a case of amnesia amongst all of North Canton's city leaders? Did you forget that you have an economic development director? The legislation to create and fund the economic development director position was passed quite some time ago. And maybe Ordinance 156-03 passed on December 15, 2003, is too far in the past for many of you to recall. That individual's - Mayor Tom Rice, if you do not remember, you appointed an individual to fill the position of economic development director. That individual's name is Eric Bowles and his annual salary is \$60,669.44 annually. Mr. Bowles' first day as the North Canton Economic Development Director was July 20, 2005. Mayor Rice, I would like to know why your economic development director was not made immediately aware that three dentists were attempting to expand their entire dental practice to North Canton and bring with them at least sixteen professional quality jobs until I relayed this information to him in a phone conversation last Thursday, August 25<sup>th</sup>? On July 6, 2005 the applicant for the zone change for the dental facility met with the North Canton Planning Commission and found little if any interest from the members of that commission. Where was North Canton's former Economic Development Director and now City Administrator, Mr. Michael Miller's support when the developer attempting to bring this dental practice to the City met with the North Canton Planning Commission? Where was the backing and support of the office of Mayor Tom Rice for the addition of sixteen professional jobs for the City of North Canton when this zone request was put on the July agenda for the Planning Commission? In last week's public hearing, the developer explained there would be no requests for tax incentives or abatements. They simply wanted the needed zone change so they could build a professional dental facility. This would bring new professional jobs to the city, income tax to the city coffers and property taxes to support the North Canton City Schools. Property available for development in North Canton is limited under current city boundaries. The chance to bring quality professional jobs to a city with very limited land available for development should have the highest priority. Everyone in this room as well as the citizens of North Canton should be asking why Mayor Tom Rice and City Administrator Michael Miller are not utilizing North Canton's Economic Development Director. On Thursday, August 25, 2005 I phone Mr. Eric Bowles and told him of this planned professional dental facility and provided him with a name and phone number of the developer. On the same day, I provided the developer with the name and phone number of North Canton's Economic Development Director. The next day the developer made two attempts to phone Mr. Bowles, but was told that Mr. Bowles was in meetings. By the end of the business day Friday, August 26, the developer and North Canton's Economic Development Director still had not made contact. This opportunity to bring sixteen professional jobs to North Canton should be top priority for everyone at City Hall. And the leadership on this should come from you, Mayor Rice. A great deal of rhetoric coming out of this city for the last several years has been everyone's commitment to economic development. In light of the way this development is being welcomed or should I say unwelcomed, it appears that talk of economic development for North Canton is clearly just that, talk. I hope that I am wrong. I ask that Mayor Tom Rice and City Administrator Michael Miller urge North Canton's Economic Development Director to do the job he was hired to do by actively supporting Mr. Eric Bowles with more than public rhetoric. I got word late this afternoon that Mr. Bowles and Mr. Sahadi have finally made contact. I still am quite concerned at the very first day that Mr. Bowles took office and was on the city's

payroll for almost 61,000 a year. Mayor Rice, I would like to know why Mr. Bowles wasn't given this mission from day one?

Mr. Miller: I believe I can answer that question. Mr. Sahadi, and I'll go get my notes on the project, came in late this spring, early this summer, with a project where he wanted to bring in a dental office. He did not identify the number of jobs. He met with me personally and wanted me not to bring up the subject to the Mayor because he felt that the Mayor and he had bad dealings in the past and wanted me to deal with it personally. When Mr. Bowles came on board I was still dealing with Mr. Sahadi personally. In fact, I talked to Mr. Sahadi this morning and explained to him part of the problem with this situation was that in this case the ward councilman was not consulted between Planning Commission and here, that he needed to personally speak with Doug Foltz. I talked to Doug Foltz today about that same subject. It is something that Mr. Sahadi and I have been discussing actively. But when Mr. Sahadi and/or anybody with a economic development project comes in and says I want it dealt with in a certain way, you have to respect their wishes. Economic development is not done in a public forum. Economic development is not a thing where you get a thousand batting average. Economic development is just working all the leads that you can and trying to get economic development to happen. Mr. Sahadi still has not shared with me how many jobs he plans to have in this dental office. Mr. Sahadi indicated that if he could not get this site, he was not going to look at a location in North Canton; he was looking to take it out to Jackson Township. We are looking to try to bring ... stuff into North Canton. We've suggested other sites, but those other sites are not something that Mr. Sahadi has any personal involvement in. So I'm not sure that he's going to look to bring that dental office into North Canton onto those other sites. This is a site that he has an option on or his group has an option on and this is the one that he wants to develop. As far as Planning Commission, I didn't, and I guess it's something that we need to talk about, is the either the economic development chairman or director or the administrator or the mayor is supposed to be a cheerleader of Planning Commission. Planning Commission is suppose to act on something that's put before it. Normally, the administration does not attend those for the Planning Commission. When it comes to Council if we're asked for input, we give input. But normally, at least as I understand it in North Canton, as I understand it from my history in Canton, both the Planning Commission - I can't recall a single incident where economic developers came down to do that presentation at Planning Commission. At council it was pretty much in deference to the ward council person That's what I talked to Mr. Sahadi about this morning. Mr. Sahadi, this morning, asked if he could catch up with Eric. I got those two together today. You know, we're doing our job and that's it. One of the things that I think is kind of puzzling to me is that how we can rezone for offices over mines that are unsafe to put trails over, but I guess that's just a personal question that I have that I haven't quite figured out yet. But we're doing our job Mr. Osborne.

Mr. Osborne: You may think you're doing your jobs, but you didn't answer my question. For years we've been looking for an economic development director and from by all impressions that I have when I met with Mr. Bowles on Wednesday for an hour, he seems to be a very fine gentleman. My question was, why wasn't Mr. Bowles, who was brought in to spur economic development and bring jobs to the city, who has a salary of almost \$61,000 a year, why wasn't he apprised of this? And why isn't he trying to, to make this become a reality for the city? And I actually addressed the question to the Mayor. Now, I think he's an adult, he looks healthy and I think he can speak for himself.

Mr. Miller: That's fine.

Mr. Osborne: This was your appointment Mr. Mayor Rice...

Mayor Rice: Yes, Mr. Osborne...

Mr. Osborne: ...why wasn't Mr. Bowles brought this information so he could quickly get up to speed and work to make this happen for the city?

Mayor Rice: Mr. Osborne, we - you just want to sit up here and argue with us. No matter what we say, as in the past, you never accept anything anybody up here has to say as an adequate...

Mr. Osborne: I'll accept anything you want to say right now.

Mayor Rice: Excuse me, but I think, do you want me to talk or not? Then I expect you to quiet down and let me speak. I've sat here very quietly and didn't interrupt you. So whenever you're done, you let me know and I'll talk. Are you done?

Mr. Osborne: I'm waiting for an explanation to my question.

Mayor Rice: Okay, you're never going to be satisfied Mr. Osborne. This is all - all your little games, your political games that you continue to come up here every Monday night on speaking night and attack the Mayor and the Director of Administration. Everybody that is

here - you have an issue every Monday night you come up. This is your latest. Trying to help out your buddy on the zone change. Mr. Miller has been handling this issue well before Mr. Bowles came in very adequately. And there's no need to, with all the things we had for Mr. Bowles to do starting day one, we didn't hand every little item that Mike and I had been working over to Mr. Bowles his first day, because it was being adequately taken care of by Mike Miller, who's very capable of handling that. So your contention that everything the day Eric Bowles came on board had to be turned over to him is ridiculous. It's not a one man job. He heads up the activities. I still help in economic development issues and Mr. Miller still works on economic development issues. So that's just a little game you're playing. And as long as we're asking questions, why don't you explain to everyone, like Mr. Miller said, why on the same road, Applegrove Road, a very short distance apart, on one end we have ten acres of vacant land that all the city wants to do is put a wood chipped trail on so the public can go walk through the green space, and you believe, in your emails back and forth between the media and Mr. Held, say you're concerned with mine safety, public safety, the possibility of liability with the city, total disregard for the welfare of the citizens of North Canton in this mine infested area. That's yours and Mr. Held's emails back and forth. See this is where the politics come in Mr. Osborne, why don't you just admit what you're doing. You know the Rotary Park is unsafe for the public. Everyone is in danger from walking in a piece of green space. But since you and Mr. Held and your buddy Mr. Sahadi want to go out and have some idea about wanting to put some development out there, just down the street from it, that's okay to build buildings. So that shouldn't be a safety concern or anything. There's a process to go hrough. The process is it goes to Planning Commission. The process is they make a recommendation for the rezoning and it comes back to City Council. It has to go through the process. It's doing that.

Mr. Osborne: Mayor Rice....

Mayor Rice: Now if Mr. Sahadi feels that Mr. Miller was not adequately addressing his concerns from day one that he came in talked to him, I'd like to hear that from Mr. Sahadi.

Mr. Osborne: Mayor Rice, you're telling me that...

Mayor Rice: Mr. Sahadi, has Mr. Miller not met your needs from day one when you came in here? Have you been dissatisfied with Mr. Miller's cooperation?

Mr. Sahadi: Mr. Miller's has been very cooperative.

Mayor Rice: Thank you. That's all I want to know. So therefore, I think you're trying to make an issue out of something; there's not an issue there. Mr. Miller and Mr. Sahadi have been working together on this. And it's going through the process. It's as simple as that. But I think you're being quite disingenuous with your concern about this project. I find it laughable that you're all for this big office complex, which is great if we can make it in the City of North Canton, that's wonderful, but to turn around then right down the street, a short walking distance on the same side of the street in the same general area, the city shouldn't be putting walking trails in there because it's unsafe. You can't have it both ways Chuck. Okay, if you're for economic development things to happen, let's not criticize the trail and sit here and champion a development right down the street. Because I'm not buying that and I don't think any common, any person with any common sense is going to buy that argument. So it's being handled and if it's not being handled and Mr. Sahadi's upset with the way that he hasn't been taken care of by Mr. Miller that, I think, is the real question. Has Mike been doing his job or not? I think Mr. Sahadi just indicated that's he's been happy with that.

Mr. Osborne: Mayor Rice, you didn't answer the question.

Mayor Rice: Well, I answered the question.

Mr. Osborne: Why wasn't your economic development director, who you've brought on board after years of talk, apprised of this situation when he came on board?

Mayor Rice: I think I did answer the question. Did anybody on council feel I didn't answer the question?

Mrs. Kiesling: You answered it.

Mayor Rice: Okay, thank you. That's the answer. I explained it to you...

Mr. Osborne: What you explained was, each of you three, yourself, Mr. Miller and Mr. Bowles, handle economic development. But nobody is facilitating and assisting this process for this particular project...

Mr. Osborne: That wasn't what I asked you Mayor. I asked you why wasn't an individual who you brought on board...

Mayor Rice: The reason he wasn't at the...

Mr. Osborne: ...for \$61,000 a year apprised...

Mayor Rice: ...on day one was because Mr. Miller was handling it. That's the answer. Does anyone else not understand that?

Mr. Osborne: Mayor Rice, this the best opportunity I've seen come knocking on this city's door in all the years that I've been actively involved up here and your economic development director knows nothing of it. Thank you.

Mayor Rice: Okay, thanks Chuck.

Mr. Snyder: Thank you. Is there anyone else wishing to speak to the Council this evening? Sir? Just step forward, state your name and address for the record.

Craig Monastra: Craig Monastra, 185 Creekside Circle, NE. I was here last week and I thought this week one of the agenda items would be the vacating of the two streets and I noticed it's not on there. I prepared something for that and if you don't mind...

Mr. Snyder: My apologies. I, and I will, I know Council, there were some questions with the Law Director so I asked that that not be placed. I apologize if we did cause you but we'd be more than willing to ...

Mr. Monastra: Ok.

Mr. Snyder: ...because we will be looking at that again next week.

Mr. Monastra: Ok.

Mr. Snyder: So if you please address your concern.

Mr. Monastra: That's fine, I'll just read from my notes then. If that's ok?

Mr. Snyder: That's fine, thank you.

Mr. Monastra: Basically, just a few comments. Vacating these two streets will jeopardize the safety for the future of 118 families of the Sanctuary. The Planning Commission, the Fire Department realize this and have asked Council to reconsider the 2001 decision to keep these streets closed. The Planning Commission stated that keeping these streets closed creates a safety hazard and is a bad planning choice. Out of curiosity I went there yesterday, just to drive the distance from EMS to the dead end at Weber and also EMS going all the way around, I knew the shortcuts, to Applegrove and then into that area. EMS to Weber dead end is basically six-tenths of a mile. It took me under two minutes driving the speed limit of 25 mph. The other route, EMS down Dogwood, down Holl, down Hyacinth to Applegrove, to the front of the north side of Sanctuary is basically 1.2 miles. It took about five minutes. Of course, doing the speed limits, numerous stop signs and then if there was an emergency on the south side of the Sanctuary you still have to go through that. So there could be you know a quite a few minutes difference. The same would be true for the Fire Station, which you know is in the very same area. And also if there was a fire or should I say a police emergency and the cruisers were on the south side of the city, they'd have to go through all those mazes to get up there or zoom up Main Street. I basically thought it would unwise to vacate these two streets without some type of an alternative giving southbound access into that allotment. And really there's nowhere else down unless you were to tear down a house or put in a heliport somewhere and fly over it. As I said, the Planning Commission, the Fire Department, expressed their opinions on the matter. There will be 118 families up there and the councilmen look out for their safety and protect their rights since they can't be here today to do that for themselves. I also have one question, it's also a legal question, so it's kind of funny. I have a scenario, so let's assume that the Sanctuary resident get severely injured or dies; for whatever reason some type of breathing problem. EMS responds at an acceptable time. However, the minutes that they lost by going all the way around the city could have saved those people. Now without looking at alternatives, is the city or the council liable due to negligence because they ignored the Planning Commission and also the Fire Department in opening up a southbound access. I mean, I've read through the newspapers there are other issues where EMS fail to respond in a timely manner. And it is public record that Fire Department and Planning Commission said, you need to open up southbound streets. So is there a possibility of some type of civil suit that come - could come back from the family who's - or is that something you really shouldn't answer right now Paul? It's just something that crossed my mind because I deal with due diligence and due care all the time and without an alternative, you could have negligence.

Mr. Pusateri: But I - and I will say that the likelihood of liability is slim if not none. I mean there are - the delayed cases you're talking about is where there's an established fire house, an established route to a particular house that for whatever reason there's a delay because the fire department didn't do something properly, based on the established route, then they're liable for that delay but...

Mr. Monastra: But that would be like...

Mr. Pusateri: ...the plan of the City, plan of the City in putting fire departments in certain portions of the City. I mean there are probably other places in the City, I'm not sure, that takes longer to get to. I don't know for sure. But that is not an issue where a City can be held liable.

Mr. Monastra: Then a final comment. Why vacate both streets? I mean why not work with the developers, Planning Commission, EMS, Fire and figure out which of those two streets would provide the best access you know to funnel traffic in and disperse within the Sanctuary and then vacate the other? Why do both of them at one time? Last week I was here at the council meeting and someone, I don't recall who, it might have been Marcia, made a comment that the council needs to look out for the good of the City and sometimes that impacts a few individuals. So for the good of the City, I think you should not vacate both of those streets. That's all.

Mr. Sarbach: Sir, I believe there are three streets going into that area. And two of them have been vacated as through streets.

Mr. Monastra: Which is the other street?

Mr. Sarbach: Woodside which turns into Woodherst that goes on the western side of the Sanctuary.

Mr. Monastra: Woodside...

Mrs. Kiesling: It dead ends ...

Mr. Sarbach: You know, where the four way stop on 7th Street.

Mr. Monastra: On 7<sup>th</sup> Street?

Mr. Sarbach: Nearest the high school.

Mr. Monastra: Yea, I know where that is.

Mr. Sarbach: If you go north from there, that goes...

Mr. Monastra: So where Jeff - Mr. Peters lives, you mean back ...

Mrs. Kiesling: Yea, where Jeff lives.

Mr. Sarbach: Exactly, that dead ends right at Jeff's ...

Mr. Monastra: So that's another one that you're considering there then?

Mr. Sarbach: That's not one we're considering. That one is still a ...

Mr. Monastra: Okay.

Mr. Sarbach: A street.

Mr. Monastra: A lot of the information that I pulled from the June articles Repository because I wasn't at the meeting. So if that's true then at least there should be some southbound access. I mean, I've - I live in that neighborhood actually and I noticed that there's basketball courts in the street at the end of Weber and those type of things and I wouldn't let my children play in the street. So I'm just saying look at the whole public safety issue before vacating those streets. Thank you.

I think when it was all said and done and I'm going by memory, it might be off, we were going to actually pay the appraised value as far as general fund costs were concerned. And I believe that appraised value was – was it 16,000 an acre?

Mr. Snyder: 17.

Mr. Miller: The appraised value was...

Mr. Foltz: 17, okay.

Mr. Miller: The appraised value was 10,000 an acre. We would of been paying 10,000 an acre out of water funds.

Mr. Foltz: Well, I'm just doing it longhand. But it's a lot more money than - we're getting hung up on \$10,000.00 out of our general fund. And you know I think there was other support on council. The second one was Stark County Petros Park, which might get our grant once we return it back. A total of \$1,280,000.00 for 30 acres. That's where I made my mistake, I wrote on the wrong line. So that was \$42,000.00 an acre. They had Clean Ohio funds to help them with that, but still that was their bottom line paying for those - for that land acquisition. So I just - I wanted to pass this down. I think we're missing an opportunity here. I don't want to belabor the point, because I think it has been discussed before. If everyone wants to look at that. But, that just brought a realization to me. Mike Miller chairs this committee. I think he brought it to our attention. I thought it was a good buy at the time. I know there was other concerns as far as water fund money. And I'm not trying to pin this on anybody else on council, but I just think it's - I'm just disappointed that we're - at this time we're going to give back \$108,000.00. Especially when I read the paper and I work the Canton parks, we recently a \$200,000.00 grant, a federal grant from Mike DeWine, and then I think Massillon just got \$180,000.00 through Nature Works. I think that was in the paper last week, for once again nature. So I just wanted to make the Council aware of that. I think Mike's doing a good job to present these grant opportunities to us and I feel we should take a hard look at these and if it's not too late I'd be willing to still try to negotiate with Crowder to buy his property. But that's my two cents worth.

Mr. Lane: I believe we were informed that it's not available any more correct?

Mr. Miller: Depends on what day you talk to him.

and there should be no delays and we should be proceeding well with that project. The water treatment plant update I've passed out to you basically the first phase of that project is complete, the second phase is nearing completion, and then phase three has begun, that's the back wash holding tank. The South Main Street project, we have suspended that project we are continuing to work the contractor on that. And I believe I mentioned before it should be at no additional cost to the City. He should be able to hold his cost and we should be able to in fact save some money on that project. We're looking at some elements of redesigning them working with the contractor that will decrease the cost on that project. But right now we're looking at starting that project up on April of 2006. And the last item I wanted to mention, we're starting a preliminary design for a bridge in Hoover Park for the walking path there over the Nimishillen Creek over there. So the preliminary design this year will probably go to final design next year then look at construction hopefully in the latter half of next year. So that's all I have.

Mr. Snyder: I have one question, and I apologize I'm out of turn. But you did bring up that South Main project. I noticed that right at the corner of - would be to the northwest corner of Everhard there that in the right away, our crew and somebody else, was that - were they installing - is that some kind of storm line they're putting in there?

Mr. Benekos: There was the property owner there, The Gentle Shepherd, had raised their property and they needed an outfall for the drain. In the project itself we had designed a storm lateral to the property so they could drain into that. Mr. Osborne: My name is Chuck Osborne 307 Fairview Street SE North Canton, Ohio. I have to respond to Mr. Foltz's adulation of Mr. Miller concerning the Crowder property purchase which was defeated. I saw the application to the National Resources Assistance Council. This city turned down that property in 2001 for a price of \$303,000.00. Four years later they come back and the city agrees to pay \$540,000.00 for it and Mr. Crowder agrees to give back \$120,000.00. What that accomplished is that it allowed the City in their application for the grant to inflate the contribution from outside sources or other sources for the purchase of the property. I believe the application for that grant was manipulated to qualify for the grant because the grant required a certain minimum percentage of contribution from other sources. The City paid, was going to pay \$240,000.00 for it. Mr. Crowder raised his price from 303,000 to 540,000 and then turns around and says well I'm going to give you back 120,000. So 303,000 plus 120,000 that worked up to be almost but not quite the qualifying percentage that the City - that they required to qualify for the grant. I just can't stand here and watch this praise up here when I think that whole process was manipulated. And I praise this council for turning down that purchase and rightfully so turning back the grant. The grant was for 60,000 a year for three years. So when I did my research on that and spoke before this body back in February on this I noted that. We were just two or three percentage points short of meeting the minimum contribution to qualify for the grant. But of course Mr. Miller is president of that council and this is my opinion and like I said, it's very funny in Mr. Miller's own words it was a convoluted deal and it surely was. But for this city to have come back four years later when Mr. Crowder raises the price from 303,000 in 2001 to 540,000, it allowed for so many games in there it was appalling. So, Mr. Foltz I would temper my praise up here. Thank you.

Mr. Foltz: One comment. Once again Mr. Osborne, your comments speak for themselves and I don't have to add anything to that, alright

Mr. Snyder: Anyone else wishing to speak. Mr. Fano.

Mr. Fano: Yes, Dick Fano 1382 Elmwood SW North Canton. Mr. Foltz likes to be known as the park man and I want to be known as the street man. First of all thank you, thank you, thank you for my  $9^{th}$  Street. But I'm not really happy with the – it's a two-fold purpose here ...

Mr. Foltz: You're on a roll.

Mr. Fano: I just don't think that the city is keeping up with their street repairs. I mean I like the idea that — would you quit laughing - I like the idea that Main Street, South Main Street and Everhard is going to be done, but I also have reservations about anything that's going to happen in the future north of Applegrove before you get to 7<sup>th</sup> Street I'm sorry before you get to 7<sup>th</sup> Street to Applegrove. If you drive up there at any given time look out and tell me where you see a curb on the east side of that street. There are no curbs there and we're developing a ghetto in the 2<sup>nd</sup> Ward half of the 2<sup>nd</sup> Ward or half of Main Street is...

Mr. Fano: And the other half could be yours or Kathy Magel's.

Mr. Fano: So I'm going to be breathing down both of you guys' neck to get that taken care of. Now it took me fifteen years to get 9<sup>th</sup> Street done. I don't know if I got fifteen more years so I might be a little more stronger with this next project. But being part of your ward ...

Mr. Foltz: You're talking about 7th Street, north of Applegrove, Main Street...

Mr. Fano: Yea, I want some streetscape there. They forgot that for years now..

Mr. Foltz: I think that was, that was engineered at one time, wasn't it? We got utilities moved and everything.

Mayor Rice: Yea Dick some of that, that's already in process unfortunately as you know it takes a long time to get there and we can only do so much per year but these guys know because I've said it to both Mike and Jim numerous times before, I concur whole heartedly and can't wait for us to get up on North Main because if you really look at the most - well put it this way let me rephrase that... we've had a lot of new growth on the north side of town and it's not just between 7<sup>th</sup> and Applegrove but continues on north of Applegrove all the way to the city limits.

Mr. Fano: Yea but them roads is all taken care of north of Applegrove it's got curbs...

Mayor Rice: Well no it's not the curbs we still got... if you really...

Mr. Fano: You're looking to put turning lanes in now.

Mayor Rice: Well no I'm just talking about the road itself in its current condition. I'm not satisfied with that at all. You've got an absence of curbs that are broken up or they've been, it's been paved over so many times you got very little curb left or they're broken away. If you go up north of Applegrove it's the same way and that's a really bustling area of town really. We've got a lot of new developments up there, we got a lot of business, we have an awful lot of traffic up there. I personally don't think it, Main Street up there doesn't look very good for as much business and activity we've got going up there. So some of the design is already completed north of 7<sup>th</sup> Street I think up ...probably...

Mr. City Engineer Benekos: The whole road...

Mayor Rice: Isn't the design up even further? The design just the whole so far?

Mr. City Engineer Benekos: I think it's just the whole road.

Mayor Rice: And they're working now on trying to get utilities relocated. So a lot of that preliminary work is already underway, and we're trying to do that but, but know that we're not going to get to construction up there till at least 07 probably - funding wise and everything else because we got to get done with the south ends. We want to finish that because it's closest to be ready to complete.

Mr. Fano: It just seems to me that the City is putting time and effort at Washington Square and that area doing all that. And there north of Applegrove but they forgot the Square or from 7<sup>th</sup> Street up.

Mayor Rice: No it's not forgot about. Like I said it's already been - a lot of that design work has already been done and we're working on trying to get some of the utilities. So I would just want you to know that it's not forgotten about in fact it's already in process and it has been in...

Mr. Fano: Okay, I'm running out of time I want to see a nice street up there.

Mayor Rice: We'll try to accommodate you.

Mr. City Engineer Benekos: You're the inspector.

Mr. Fano: And really as far as repair on the Main Street out here - I don't know why you can't fill those cracks out there. I'll tell you what's going to happen, as much salt as this city uses on the streets and it gets down in there you know what's going to happen? It's going to bust down and it's going to be a bigger job and you're going to say well we can't do 7<sup>th</sup> Street to Applegrove, because we got to do this again out here. So that's all I got to say, thank you.

Mr. Snyder: Thank you sir. Anyone else wishing to speak?

Mr. Miller: Mr. Snyder, real quick just a couple things, the local match is 25% for NRAC so with \$240,000.00 coming from the City we could have purchased it for \$900,000.00 roughly and still been well within it. No. 2 the \$303,000.00 was 15,000 an acre because we were getting four more acres. So it went from 15,000 in acre to 17,500 and the ultimate purchase price went down out of the City's pocket from \$303,000.00 - if you will down to \$240,000.00. So we're actually saving \$63,000.00 from what we were going to purchase it for three-four years before that. Just some corrections.

Mr. Snyder: Thank you sir.

Ms. Bevan: Linda Bevan 1359 Willoway. You talked about putting in the light at Mississippi. Are you going to fix the street because it's like a roller coaster? I had my granddaughter and we were walking up the street, thank goodness we were over by the KFC. And a lady came out of Pershing and hit that sunken part, and almost hit that fire plug.
