Mr. Held: Yes, the City of North Canton recycling program was met with great success this year. It's an example of a cooperative effort with the City of North Canton and the Joint Solid Waste District and our residents. The number of homes that participated last year was 1,551. The number of homes that participated this year was a 437 percent increase - 6,774 homes. The total tonnage that we had collected last year in leaves was 83 ton and the tonnage this year was 185 ton. So that was a 223 percent increase. Great success with that. And we attribute the large increase due the grant that we received from the Joint Solid Waste District that allowed us to provide free bags to the residents. That's all.  
  
Mr. Snyder: Thank you. Mr. Mayor, you got any comment?  
  
Mayor Rice: A couple quick things, Jon. Number one, we got a notice back, I assume Mary Louise got one of these too on that. The Orion Road annexation has been approved by the Stark County Commissioners. So that will be coming after its waiting period time to City Council. But that small annexation there on Orion has went through that process successfully so far. My only other comment would be to notify council and the community that the Hoover union has been voting yesterday and today on their tentative agreement that we talked about here a couple weeks ago. Their ratification vote took place yesterday and today as I understand it. And the results of that vote will most likely be announced some time tomorrow. Which we're hopeful will be a positive vote to ratify that new contract. And I just would comment that many workers at the Hoover Company in recent months have lost their jobs. The current workers over there, as part of this package, are going to be giving some concessions back to this new contract, some health care issues, some retirement benefits and some work rules. And obviously we ... we're approaching the holiday season and the end of the year some people are entering this season without jobs, others with reduced benefits, but they're doing what they're doing in showing great leadership I think because of their commitment to this community. Because they want to make sure that the Hoover Company and the jobs that are there remain in this community for the immediate future. The Union President, Jim Repace, and the Hoover President, Tom Briatico, have shown great leadership in this, along with our business community, our residents and the City Administration. We've all worked tirelessly over the last two years to get where we are today, which is keeping as many jobs as possible, manufacturing jobs, here in North Canton. When many people over the last couple years have repeatedly said that Hoover was done and

Mr. Snyder: Inaudible... as the Mayor pointed out to you, we have had a couple of conversations - two or three conversations and we've gone over this. I would urge any member of council who has not done so, please contact the Mayor these next few days, give him a call and set up an appointment, he's more than willing to talk to you about his program and his hopes and his dreams for that department. And as he's pointed out, what he wants to do and once they put that into place across the street, I'm sure they'll be talking to us about things that we can do to help them along to - so they can fledge along and stay here in the City of North Canton. As the President of Council and as the Chairman of Finance, it is indeed a privilege to sit here and to pass a forty plus million dollar budget when most cities in the county, the state, in the United States, cannot pass a budget that is balanced.
