7. Recognition of Visitors

Mr. Snyder: And before I open the public speaks I'd just like to thank the young students here with us in the audience. Member Kiesling spoke at the school and since that we've had these young children joining us and we very much appreciate it and please come back again. At this time we'll recognize any visit - anybody in the audience wishing to speak to the council. If you step forward please state your name and address for the record.

Tom Irwin: My name is Tom Irwin. And I live at 716 Briar Avenue NE. At the February 10th council meeting I spoke of the number of goals that I wished to attain at - by coming here and speaking about the signal at Wilbur and North Main. After - one of those goals was the warranting of that signal. After the meeting one of the people that I worked with brought it to my attention that the signal is not warranted. From the letters from ODOT and in the opinion of the Stark County Traffic Engineer, the wrong traffic generator was used. Using the correct generator, it's still not warranted and this came from Lisa Jaynes, this is from ODOT. To give you a little background about Lisa, she's a highly respected traffic engineer. To put it real

simply, when Lisa speaks traffic engineers listen. So basically by ODOT they would reject this warrant. The mayor described the intersection at the last council meeting as being dangerous. And I thought maybe the mayor knows something I don't, so maybe I should investigate this further. So I asked Mr. Osborne if he could obtain the accident records for the last three years from the Ohio Department of Public Safety. And what the Ohio Department of Public Safety does is they collect the accident reports from our local law enforcement agency, the Sheriff's Department and the State Highway Patrol. So therefore we have all of the accidents. For the year 2000, at the intersection of Wilbur and North Main, we had 3 accidents out of a total of 491 for the entire city. For the year 2001, we had 2 accidents out of 448 total accidents for the city. And for last year we had 1 accident out of 415 total. As you can see the accidents for the entire city are coming down. I personally attribute that to our law enforcement. I like it when they hide behind dumpsters. All these accidents were property damage, there were no injuries involved at all. With only 1 accident last year I personally cannot consider this to be a dangerous intersection. The mayor also informed us that Swensons - Swensons basically whether we put the light there or not there's no preconditions with Swensons, they're coming regardless. So it doesn't make any difference if we put the signal up or not they're coming. We're not going to lose a business, I don't consider this to be a dangerous intersection, especially with only 1 accident last year and it's not warranted. So with that in mind I ask you to ask yourself this question, when the citizens I represent ask me how I can justify spending \$110,000.00 of their tax monies on a signal that is not warranted, is not at a dangerous intersection and won't mean the loss of a business in our community, what will be your reply? Thank you.

Mr. Snyder: Thank you sir. Anyone else in the audience wishing to speak to the council this evening? Mr. DeHoff.

Bob DeHoff: I'm Bob DeHoff. I have a business at 821 South Main Street in North Canton. I live at 7700 Mudbrook in Massillon, Ohio. Tonight I'd like to address the city on a partnership that we have been working with between Plain Township and the City called a Cooperative Economic Development Agreement, henceforth the word CEDA. Believe it or not we've been working on this for over three and a half years. This project started with Mr. Lemmon and myself back in the Fall of 1999. In the first part, I think January or February of 2000, we talked at that time with the city on annexing this piece of property into the city. It's been a long process from where we began to where we are here today. In the past few months as you know we have been working collectively with Plain Township officials, the City, concerned citizens within the community, on important negotiating points for this CEDA agreement. I believe council has been - has received a copy of this draft. One of the issues very important and frankly something that I think should hold great merit is the question how will the revenue of the sanctuary compare to the cost? Certainly in today's budget cutting realm that all political subdivisions find themselves in, that is an important question. In the late of last year we asked the Director of Finance, Julie Herr, to prepare a chart - to prepare numbers showing the revenue generated from this development. Once we received those we needed to put a cost together and we asked again Julie Herr to calculate the estimated cost in terms of fire, EMS, police and certainly roadway improvements. And I'm here tonight to tell you that we've made some changes to our plan. Three years ago we had an independent/assisted living type of a building. Today we have eliminated that and we're proposing condos/apartments. So the mix changes rather dramatically where before right on where the barn kind of sits we had a 100 assisted living units, now we have 95 condos/apartments. I think where we had 85 condos, Julie we now have 60 in the lower level overlooking the pond. And we're hoping that your numbers I believe will soon be disbursed to council. I think you will find that it is a significant revenue generator for the city. But in doing this process the last couple of years and kind of going back to the drawing board, as you know we've changed our land plan several times. I was reminded that 11 years ago what we're doing - what we're proposing to do was really spelled out in the infamous North Canton Enhancement Plan done about 11 years ago, published in the Fall of 1992. I'd briefly like to read that plan regarding annexation. And this was something that certainly other council members back in '92 were sitting where you're sitting - but frankly several things in this enhancement plan have come to fruition in this city. We've talked about improving Main Street and that certainly - you've had a wonderful start and hopefully that will continue. Putting signs up at the entrances of important entering points to the city. That was one of our plans that NBBJ had suggested and that's recently been done and I might add very handsomely. With the city it says this, future annexations to the City of North Canton will more than likely require a strong competitive posture on behalf of the city to aggressively seek annexation and to aggressively entice property owners and/or potential developers to join the city using incentives. The City of North Canton should in any case pursue annexations that square up the service boundaries, help complete logical neighborhoods within North Canton for favorable economic reasons and the last priority should be given to areas that are within the North Canton City School system, which this property is. So things take time, but 11 years later I think this is still a good plan. And last I need to be straight forward with you this evening, we have heard some talk on the street that we, McKinley Development, should be concerned that political agendas may take priority over this CEDA. I know that will not be the case. McKinley Development is confident that this council and this city will have the city's best interest in mind and put political agendas to the side. Thank you. I have several of these reports and Mr. President I'll leave them right here, anyone that would like to take a copy they're welcome to do so.

Ordinance No. 13-03 - Second Reading

An ordinance authorizing the Board of control of the City of North Canton, through the Director of Administration, to advertise and receive bids according to specifications now on file in the office of the Director of Administration and the Mayor to enter into a contract for the installation of a traffic signal at the intersection of North Main Street and Wilbur Drive NE.

Mr. Osborne: Mr. President, just before we vote I'd like to make some comments.

Mr. Snyder: Alright sir. Well as soon as I - I'll turn it to the chairman of the committee...

Mr. Osborne: Okay.

Mr. Snyder: and then I'll allow you to speak. Mrs. Magel.

Mrs. Magel: I'll turn it over to Council Member Osborne. Mr. Snyder: Member Osborne you have some comments?

Mr. Osborne: Oh, okay. Thank you. I have some information I've collected in the last week and I'd like to share it with council and the media and the public. I'll be right -- If you haven't noticed in the last year since I've been on council I like to dig in and gather information and gather a lot of facts when I'm voting to spend tax payer funds. In voting for this traffic signal there's been a lot of misinformation put out. As Mr. Irwin pointed out, I received the accident reports for the city for 2000, 2001 and as yet incomplete, but I'm sure it's fairly well complete, for 2002 and there's a lot of very interesting information that has come from looking at these figures. What I've done is taking all the accidents that occurred at every intersection from Orion all the way down to Greenway, South Main and I've charted them in a chart. I have one for North Main accident history and one for South Main accident history. And as Mr. Irwin pointed out and I want to chart on the board here for you, some very interesting trends are emerging. For 2000 on Main Street the total number of accidents that occurred on Main Street were 229, for 2001 we have 209 and for 2002 and again this is, I forget the exact terminology she used, preliminary - they're still open the files we have 189. As you can see the accident history for North Main is trending downward, which is good for North Canton. And I too would have to attribute that to efficient law enforcement. Now city wide the total number of accidents in 2000 was 491, in 2001, 448 and in 2002, 415. So this trend is trending downward as well for city wide accidents. Now I just did some quick calculations, Main Street accidents are 47 percent of all the city's accidents as well as 2001. So half - almost of half or our accidents and I should go on here 46 percent in 2002. So half the city's accidents occur in the confines of North Main from the southern boundary to the northern boundary. Now if you go ahead and do some additional analysis and looking at the changes, city wide accidents starting with year 2000, 2001 they went down by 8.8 percent, 2002 over 2000 we're looking at a 151/2 percent reduction. Now just Main Street accidents 2001 over 2000, they're down 8.7 percent and in 2002, just Main Street accidents are down 171/2 percent. Now all this information comes from the Ohio Department of Public Safety, their trash - I'm sorry, their Traffic Crash Record System, crash listing by crash location and I have the files up there at my desk. These are very good trends and I - state records document a very good trend here and I think it does not backup statements that you know we have very dangerous intersections, especially at Wilbur. Now Wilbur at 2002, and that's the only year I'll look at this last year, again I concur with Mr. Irwin, there were five reported accidents in or in the vicinity of Wilbur. First one here occurred on a Thursday and it was a failure to yield - that was occurred at the intersection. The other four - here's one that was anywhere from 372 to 424 feet away from the intersection. Here's another one as far as 53 feet away - two of them 53 feet away and a fifth one here somebody leaving a driveway, which is anywhere from 266 to 318 feet from Wilbur. I didn't have time to closely analyze the other two years, but Mr. Irwin has done that for me. So we have one intersection accident at Wilbur. Now we have the former chief describing how it's such a dangerous intersection, the mayor describing how just - I was scared to drive up there it sound so disturbing. So I think it's important that we all be dealing with cold hard facts instead of opinions. And hopefully seeing these trends that Main Street accidents are trending downward, city wide accidents are trending downward, I would seriously like to think that council would logically rethink this position.

Mr. Snyder: Mr. Osborne I notice you list no detail - those accidents that occurred between Applegrove and Orion which are 73 of the 131 accidents that happened, happened in that quarter. Do you have documentation of how many people were transported or maimed or ...inaudible...

Mr. Osborne: I haven't detailed it that closely.

Mr. Snyder: Well if you notice sir I think that the reason why more people are using Applegrove since we went to a four lane to avoid that particular area because it's impassable due to the fact they can't make a turn a left hand turn onto Main Street. And that's, if you notice an increase in the accidents from one year to the next on Applegrove, it being a four lane limited access high - road, there's more traffic dumped onto that street now than should be. It wasn't - not designed and I think the engineer will hold out to that, it wasn't designed for the amount of traffic that it does have on it today. Inaudible...

Mr. Osborne: Well I'm glad you brought that up Mr. President. I'll give you a personal example. I was headed north on Main Street just the other day, I was in the left lane crossing Applegrove and immediately past Applegrove, I had to suddenly stop because somebody was turning in McDonald's. So I clear the right lane, I pull into the right lane and immediately I have to stop because somebody's turning into the BP. I really think the city should be analyzing some of these areas. And I was noticing vesterday there are two entrances into BP just north of Applegrove. I would highly suggest that we eliminate the one closest to Applegrove, which was in probably 25, 30 feet of Applegrove and have the one entrance probably another 30, 40 feet. That way you will not have traffic turning left and right right there at the same location.

Mr. Lindower: It has nothing to do with that intersection.

Mr. Osborne: I would also suggest that the city maybe do some long term planning and I had mentioned maybe speed reduction through town. In the area from Applegrove to Orion I would highly suggest some long term plans to widen that area on Main Street and put a left turn lane down through that entire area much like you see over on Whipple or something like that. I just - as Mr. Irwin has pointed out, as I pointed out two weeks ago from the ODOT engineers and the Stark County engineers, I believe the warrant the methodology is defective. And I believe if you just sit here and look at some of these numbers it will show you where the high action areas are and I believe you can better make legislative decisions if you have more facts at hand.

Mr. Snyder: Thank you Mr. Osborne.

Mr. Lindower: I'd like to...

Mr. Snyder: Is anybody else wishing to speak? Mr. Lindower: I'd like to say something if I could.

Mr. Snyder: Member Lindower.

Mr. Lindower: Chuck has done a good job as cover - as far as covering accidents at Wilbur and North Main. I think while he's blowing smoke over accidents we ought to be addressing the problem of traffic flow and efficient flow of traffic up in that area. I think - I feel that there probably have been fewer accidents at that particular intersection in view of the fact that people are deliberately avoiding that intersection because of the inconvenience of getting in and out of that area. There are businesses on Wilbur Drive, soon to be more businesses on the west side of North Main Street and I think if Chuck wants to really get into this thing, into the nitty gritty, he ought to be talking about traffic counts north and south on Main Street as far as improving the efficiency of being able to get out on to that street. We've talked about accidents. I don't think anybody said that that's the highest that accident - highest accident intersection in the city. It happens to be one of them though that's a very inconvenient type of an intersection as far as efficient traffic flow. So I think there needs to be other issues addressed other than the fact that whether the accident rate is exceedingly high there or not. I think the reason it isn't any higher than it is is because people deliberately try to avoid that intersection. That's all I have to say on

Mr. Osborne: I'd also like to say there's some other improvements I would suggest up in that area to get into...

Mrs. Magel: Could we stay on point?

Mr. Lindower: We're talking about Wilbur and North Main.

Mr. Snyder: Yea, we're talking about the traffic light. We can...

Mr. Osborne: We're talking about the traffic...

Mr. Snyder: traffic light...

Mr. Treadon: We're talking about this ordinance.

Mr. Osborne: accident history in that area.

Mr. Snyder: Yea well we've allowed you sir sufficient time and I have to move this along. Is there anybody else wishing to speak? Inaudible...one question. Is we do - it is my understanding we do have a warrant - signed warrant and it does have a seal by a certified traffic engineer. Is that correct?

Mr. Snyder: And that - and it does justify the traffic signal.

Mr. Benekos: Correct.

Mr. Osborne: I do have one other item that's on point here. There was a lot of discussion as to whether the manual applied to the city as a charter city. The case in Fairlawn that was heard - let's see, I don't see a date off hand, in the City of Fairlawn, but the court ruling was the Ohio Manual of Uniform Control Devices does apply to all cities including charter city and there it is if you want to read it.

Mr. Lindower: With home rule, right?

Mr. Osborne: With home rule. And if you're interested in seeing the accident reports, here's 2000, 2001 and 2002. If you'd like I'd be glad to email them to you - that's the way I received them from Columbus from the Ohio Department of Public Safety. And they have about a 20 page key because it's all in kind of coded here in numbers, I can email you that as well. But I think we ought to ... you know document what we're saying here instead of opinion and I think we'd all spend our monies better if we did it that way.

Mr. Snyder: Any other comment?

Mrs. Magel: Well I'd like to get it back into committee here.

Mr. Snyder: Go ahead.

Mrs. Magel: What I'd really like to do is spend the next half hour discussing the traffic on East Maple and the speed. However that's not a case on point. So let's stick to the issue that we are discussing a traffic light on Wilbur and it will be having a companion ordinance where we can take advantage of this traffic light on both the east and the west. And my comment was Member Osborne already or Lindower, you won't catch me on an accident on Wilbur because I am afraid to go out on it as I had discussed. I will avoid that intersection because it is dangerous. Alright now I would...

Mrs. Kiesling: I'd like to say something.

Mrs. Magel: Alright.

Mrs. Kiesling: But there's documentation that there are better ways to control traffic other than putting up traffic signals. That is the most restrictive form of traffic control, which we've been told. It increases rear end accidents, it increases people going through neighborhoods. Which I realize they're taking Wilbur to - I don't know what that street is up to Orion to get out to the light already. What's to say that's going to - I mean there's just condos and a few businesses.

Mr. Lindower: Those rear end accidents are caused by people with cell phones against their ear.

Mrs. Kiesling: Now Dave, that's pretty funny...

Mrs. Magel: Inaudible...

Mr. Lindower: I stop at signal light everyday and never been hit in the rear end yet, because of the signal light. It's inattention of the person approaching that stopped car.

Mrs. Kiesling: But we don't...

Mr. Lindower: It's got nothing to do with the intersection or the light.

Mrs. Kiesling: But what it has to do with is traffic flow and providing gaps in the traffic for people to turn safely. And Mr. Irwin and I've and Chuck's done so much research, there are other ways to control flow and that's all we're saying here.

Mr. Lindower: You could put a stop sign on Main Street and maybe that would take care of it.

Mr. Snyder: Is there any other comments?

Mrs. Kiesling: I thought you said the other night you said were open to listening to everybody's opinion.

Mr. Lindower: I listened to it. Mrs. Magel: Over and over.

Mrs. Kiesling: But you're openly criticizing.

Mr. Lindower: I'm ready to vote.

Mr. Snyder: Alright. Mr. Foltz, you have comments?

Mr. Foltz: Yea I'd like to follow up if I may. I don't know about the rest of the council and I think Kathy you alluded to it and Dave, I'm in that area at least five times a week. Mr. Bourlas has built his building there a very nice structure in the City of North Canton. I think that's the first building he's putting up there might be a second phase, I'm not quite sure on that. That's going to generate more traffic. DeVille Development there has some vacant store fronts that they've just recently filled. That's where we're going to realign the curb to meet this traffic signal. That's additional traffic. Obviously the drive in restaurant is going to be a huge success here in North Canton as Maxie's was, that's going to generate

more traffic. For those reasons alone I'm proactive and very much for this light. I've traveled it, it is impossible to turn left out of Marc's or any of those other stores - Arby's, any of those other stores up there mostly anytime of day.

Mrs. Kiesling: But you can't put a light everywhere.

Mr. Foltz: If we looked at everything that need warranted in this city other than our home rule ability to do so, this would be Daytona 500 in this city. The best decision I ever had as far as input and I'll use this as an analogy, was a stop sign, it was a two-way, at the corner of Pierce and 7th. Because there were so many missed accidents there it did not make - it did not justify the stop sign according to the state statues. But when I seen city residents almost get killed on that street and also our EMS people, there was no doubt in my mind we made the right decision. There was also input from the schools, which we had school buses traveling there. I have never second guessed that decision, I won't on this one either. I know we have different views on this. I appreciate the research Mr. Osborne. But I'd like to be proactive here and head something off before it could get real serious at that intersection.

Mr. Osborne: I'd like to say if you look at Holl Road on that chart or either one of those charts, it has as many accidents or more than Wilbur. So I - logically then I could assume that we're going to be putting a light at Holl Road here sometime in the near future.

Mr. Snyder: Chuck...

Mr. Osborne: Would that be that true Mr. Mayor?
Mr. Snyder: Please reserve your sarcasm ...inaudible...

Mayor Rice: It's a possibility...

Mr. Osborne: I'm not trying to be sarcastic.

Mr. Snyder: Well that sir I've given you time to speak...

Mr. Osborne: Holl Road...

Mr. Snyder: and if you have nothing...

Mr. Osborne: Holl Road has 13 in 2000 as opposed to Wilbur's 9, Wilbur has 10 in 2001 as opposed to Holl Road's 9 and then Holl Road had 6 as opposed to Wilbur's 5. So it has a higher accident rate than Wilbur. So...

Mr. Snyder: Well I would like - the only that I would like to say and I'll call the vote. If I would be responsible for not fending off at least one accident, whether it'd be a party being hurt or a car being crushed and I voted no for the light and I could of saved it, I don't think I'm doing my duty. As well as I am not a traffic engineer - I don't profess to be one. I believe in the administration to have the warrant that justifies it. So with that I'd like to call the vote.

Mr. Osborne: Well that's why I've consulted traffic engineers.

Mr. Snyder: I've called the vote sir. I've called the vote sir.

Mr. Osborne: And I've also consulted the state...

And if I may say Mr. Osborne, the reason there's an emergency on this is not it's contractual, but the best bid prices come this time of the year before the plants open and they want our business and we save significant money by bidding it prior to the season when they're busy. Am I right, did I phrase ... Mr. Held ...inaudible... Mr. Held: Yea, that's correct.

Mr. Snyder: May I... Mr. Osborne: Well I...

Mr. Snyder: Go ahead sir. Excuse me.

Mr. Osborne: Oh I understand. I just didn't know if maybe - again it's these kind of items the public would not have any great concern. They're looking to us for to handle these kinds of processes. But again I just thought you know if we just did this a month ago we wouldn't have to do it on emergency.

Mr. Snyder: That's a good point. Any other questions?

Mayor Rice: Mr. President can I...

Mr. Snyder: Sure.

Mayor Rice: Add to that? Mr. Snyder: Mr. Mayor.

Mayor Rice: Couple things, number one it's been said before, why does the city, in regard to our budget appropriation, why was that done on an emergency. Well if you look at your charter folks, number one, everybody in this chamber that's an elected official is up for reelection and we seat a new eight elected officials every other year. On what date, December the 1st. Okay. Now to go through the regular three reading process you need what, at least six weeks for the three readings because it's read times every other week - that's a six week time frame. Then the mayor has ten days to sign the legislation and then it doesn't go into effect for 30 days beyond that. Due the math. Would it be impossible to pass an appropriation budget with a council being seated on December 1st and get it done and place before the end of the year? Because it takes a lot more than a month to get the budget appropriation passed through regular channels. That has nothing to do - unless you want the previous council to set the budget for the following year, it's impossible by law to pass your budget appropriation in any other fashion than an emergency. Does everybody understand that? Okay, you're talking 10, 11 weeks you need to go through the normal channels roughly. Is that right Mr. Treadon?

Mr. Treadon: Sounds about right.

Mayor Rice: You're looking at least about a 11 week period of time you'd have to start to get that done to go through a non-emergency process. So this attempt by people to criticize the way the city does business. Especially in regards to the budget appropriation having to be how it's so terrible that we do that on emergency, please tell me how else you want to do it. You seat a council every other year on December the 1st, that's by your charter folks. You don't have 11 weeks in the month of December to pass the budget appropriation. That is why they normally waited over the years it's been presented to council in late November that council gets it and whoever is in office starting December 1st reviews the budget appropriation and passes it on emergency prior to the end of the year so the city can operate. Okay. Some of other contracts folks, because you don't establish your budget until the end of year, we cannot start asking to do these contracts and jobs until after the first of the year until a budget is in place. Now if you want to in future years we can put everything for the whole year on the very first council meeting in January and start to do it. We generally try to spread these things out because it's pretty routine business of buying gasoline, contracting to stripe streets - this is pretty routine business.

And I was going to distribute it tonight but I've noticed a change that I'd like to make so I would ask that I can just wait and distribute it tomorrow.

Mr. McLaughlin: Is it - can I ask a question on that? Is it just a projection of what you think... Mrs. Herr: Oh yea, projections...

Mr. McLaughlin: I mean we're just talking - this is one of those hypothetic little situations that it could it, it could not ...

Mrs. Herr: Oh yea I mean it's you know based upon projections and estimates and you know... Mrs. Magel: Wishing and hoping and thinking and praying.

Mrs. Herr: Exactly I mean and what I've used is actually a projection of nine years from now when the development is you know projected to be complete.

Mr. Foltz: Okay.

Mrs. Herr: Just for simplification purposes otherwise you know obviously there can be a billed out scheduled as to when you know all these homes and condos and apartments are going to be constructed. So...

Mr. McLaughlin: Did you take - did you take into consideration on - since he took the senior access living complex out and he put the condos and apartments and you take into consideration you know the hypothetically what property or what city income tax and every...

Mrs. Herr: Oh yea, yes. A lot of those revenue projections I had already done earlier, but I did make some adjustments for these changes. But where it really effects it is in the expense side of the analysis.

Mr. Snyder: And that's predicated on the south side being annexed to the city. Is that correct? Mrs. Herr: Yes.

Mr. McLaughlin: Can I ask one other question before you do - before you - when you say it's a hypothetical, is there a situation where you can do one where you give us the worst scenario? Mrs. Herr: Well I think in my projections I think I've been conservative.

Mr. McLaughlin. Okay okay.

Mrs. Herr: So you know...

Mr. McLaughlin: I'm just asking that question you know I just want to...

Mrs. Herr: I'm not saying that things are going to be you know any worse than this or better than this, but you know I think I have - I think I was conservative in my estimates on you know on both sides revenues and expenses. So ...

Mrs. Herr: So basically you look at the reverse saying that 70 percent we would not be collecting additional income...

Mrs. Herr: tax from because they already you know work in North Canton or they work in a city where they already are paying income tax.

Mr. Snyder: None of that has been determined has it?

Mrs. Herr: No. I mean it's still you know - but again you know I tried to make this as simple as possible - if it is possible and I kept that out of the equation because again I felt that it would you know chances are likely that it would be a wash if that's the way it goes.

Mr. McLaughlin: And the water is definitely out of the question?

Mrs. Herr: Yea, there's nothing in here regarding water or even as far as you know storm sewer lines and things like that. All of that is projected to be paid for by McKinley.

Mr. Osborne: Mr. President, may I...

Mr. Snyder: Yes sir, you may.

Mr. Osborne: Julie, do you show any kind of an impact, positive or negative, toward the North Canton

City School systems with the influx of new residents in that projection?

Mrs. Herr: Well whether it's annexed or not it's going to be North Canton City schools.

Mr. Osborne: Okay.

Mrs. Herr: So it doesn't have any impact.

Mr. Osborne: No bearing - okay.

Mr. Snyder: Any other questions ...inaudible... Director of Administration Held.

Mr. Held: Yes, all of you should have a copy of the annual report for the Police Department. Do you have that?

Mr. Lindower: Inaudible...got one.

Mr. Held: Okay. And the Chief of Police, Mike Grimes, put that together with his police officials down there did a real nice job and if you have any questions on it don't hesitate to give us a call.

Mr. Snyder: Mr. Mayor. Mayor Rice: No report.

Mr. Benekos: Just one item. I wanted to prep council. In a week or three weeks I may be bringing legislation to enter an agreement with the county for cooperation ... purchase of some GPS surveying equipment. This is for the county's CORS System - it's a Continuous Operating Reference System. It ties into the satellite so we can do some surveying based on the satellite system. It was not in the budget specifically to enter into an agreement with the county but I did have some money in the budget under the sewer collection system analysis to purchase these units so that we could go out and do some surveying. It'd be more prudent to enter into an agreement with the county and join forces with them than for us to do it all on our own. So I just wanted to prep you on that so when you see it in a couple weeks it doesn't surprise you.

Mr. Lindower: Is that basically for mapping Jim, is that what that's for?

Mr. Benekos: Correct.

Mr. Osborne: What funding level are you talking about?

Mr. Benekos: In - about 25,000.

Mrs. Magel: If I may interject. I think you've been asking for this for at least three years. We've been discussing this and...

Mr. Benekos: Well we've been discussing GIS...

Mrs. Magel: Oh.

Mr. Benekos: and this would support that in the future. It's the equipment we would need to assist us in a GIS in the future. That's correct.

Mr. Snyder: Madam Clerk, do you have any comments?

Mr. Snyder: Member Foltz.

Mr. Foltz: Yea just a few follow up comments. I totally agree with Mayor Rice and excuse my English here but if it ain't broke don't fix it. That doesn't get any simpler than that with how we run council up here. We're a very efficient city. I've seen other entities that don't even get the vehicles or the projects underway in the same year that they supposedly are going to approve it. I hear from a lot of contractors, developers, people in business that they're just amazed that a city of our size, the amount of infrastructure work, the amount of efficiency that comes out of our city as far as the government all encompassing. And I think that speaks well from us. When there is a difference of opinion, obviously as this street light at Wilbur, this is how the system works. We have two council members that aren't supportive of it. We've had discussion on it, debate on it and allowed for public input. I think that's the way it should work. But as Mayor Rice indicated a lot of this is business as ususal. And I like to see us get the trucks out there, get the projects started and completed within the same fiscal year if at all possible. I think we owe that to our constituents here. And just to follow up on the appropriation ordinance, I researched with Gail in the Council Office and it's been done that way the last 22 years and probably it's been approved that way ever since the inception council here through the charter. I don't say that for sure but I've never had a problem with it. If we have to appropriate 30 million dollars we always come back to it in a committee in a legislative form - that's the bottom line and there's room for input there whether it's on emergency or three readings. So the wool is not being pulled over anybody's eyes. The public is always welcome for their input. People can call or write me or just you know call our council office. And rarely do I have people that are concerned with the decisions we're making up here - rarely do I get a call about it.
