### 7. Recognition of Visitors

Mr. Snyder: At this time is there anyone in the audience wishing to speak to the Council? If so, step forward, state your name and address for the record.

Mr. Osborne: My name is Chuck Osborne, 307 Fairview Street, SE, North Canton, Ohio. I would like to address my comments to this Council this evening regarding the recent expenditure of funds to place a sign at the Akron-Canton Airport and ask how anyone thinks this expenditure will generate any financial return on investment for the City of North Canton. Yes, North Canton is a nice place to live. That is why we all choose to live here. But so are

thousands of other communities throughout the United States. When a business spends money for advertising, central to that expenditure is a product or a service that is being sold. And in the sale of that product or service, the advertiser will recoup the cost of the advertising expense when a product is sold or a service is provided. The Repository reported last Wednesday, January 5, 2005, that \$40,000 was being spent from the City's economic development budget for a sign and promotional materials at the airport. Mr. Miller I would like to thank you for the time you took to draft a letter to me detailing the various expenditures that have been made to date regarding this promotion. But for some reason, your figure of \$1,600 breaks down into \$900 deposit and \$700 for first quarters rent on the sign, does not accurately reflect the full sixty month costs to lease the sign location at the airport. I have talked to the advertising firm, INTERSPACE, that handles the advertising at the Akron-Canton Airport and learned that the contract for the airport sign is for sixty months at a monthly rate of \$300. This will, will result in a cost of \$18,000 just for rental space for the sign at the Akron-Canton Airport. How will North Canton recoup the expenditure of funds for this sign? What is it exactly that the City of North Canton is selling? Is it selling the fact that people could come to North Canton and have a burger at Swenson's on North Main Street or get their car washed at the Super Wash on East Maple Street? If this sign does result in increased retail activity such as this, will this generate enough income to the City of North Canton to offset the \$40,000 in advertising expenses that have been expended? If this expenditure of \$40,000 could increase the number of well paying jobs and commercial businesses for the City of North Canton, the next question is, where would you locate any new business that desires to be in North Canton? I am familiar with the loss of two North Canton businesses in the last year or so that left the City because there was nothing available in the City to accommodate their needs. One of the businesses was a small manufacturing facility that was lured away from North Canton because they had, had outgrown their facility and there was no suitable facility to move to in the City. An interesting aside when I talked with the owner of, last night, the owner told me he was unable to get anyone from City Hall to assist him when he called to inquire about relocating his business within the City. This business owner who had operated in the City since 1980 also said that North Canton was anti-business. This business has moved out of the City and along with it, nearly thirty jobs. More recently, North Canton lost another business that had operated in the City for the last six years and was forced out of its facility on North Main Street by the landlord. This facility was Stark Security, owned by former Canton Mayor, Richard Watkins. Although, former Canton Mayor Watkins wanted to remain in North Canton. no suitable facility could be found. Stark Security has now recently relocated its business out of the City. North Canton has no industrial park, no office park. There is no land for development that will bring substantial numbers of well-paying jobs to the City. So, I have to ask, how will the expenditure of tens of thousands of dollars for this sign at the Akron Airport pay for itself? In my conversation with INTERSPACE, regarding airport advertising, I discovered that the only other municipality that has signage at the Akron-Canton Airport is the City of Akron. Why does the City of Canton not have signs at the airport? Do you think the City of Canton is missing out on a great venue in which to present itself to the public or do you think Canton feels that funds expended in this manner are not cost effective? Everyone knows that Canton has plenty of facilities available for development, unlike North Canton. Many communities in Stark County have both land and/or facilities begging for new business but apparently they do not believe it is cost effective to place a sign at the airport. What will the expenditure of these funds bring to the City that has no acreage for development? It looks as though you are spending public monies for pie in the sky as you wish on a star that something miraculous will magically restore the thousands of jobs that have left North Canton along with the Hoover Company. All of this time and money spent for a lovely image when the businesses you already have in North Canton are being ignored. I visited with businesses when I was a councilman and the first thing they would tell me is that I was the first person from the City to ever meet with them. Mayor Rice, I would like to know what you do as Mayor to retain existing business and what you do to attract new business and jobs to North Canton. And, I do not mean more part-time car hops or part-time gas station clerks or part-time car wash attendants. Mr. Dick Fano, the owner of Aero Tech as well as Laura's, has been begging for relief from sanitary and storm sewer damage for years for his two businesses on North Main Street. As a councilman, I saw residents come to this Council begging for relief and asking for assistance from similar damage. I personally know of residents who have left this City because of flooding issues along the Zimber Ditch. The \$40,000 that you are literally throwing away would have gone a long way to shoring up Mr. Financial's economic ties to this City and shown him that this City does care about his business and what his business means to this City. If residents were provided timely assistance from flood relief when requested recently, they too, would feel that North Canton values their contribution to this City's tax base. North Canton has many infrastructure issues, inferior waterlines that affect water quality and fail to provide inadequate fire protection, flooding from major tributaries that have been ignored and sanitary and storm water problems that plague many areas of the City. Creating a lovely image, as the Repository calls this campaign, does nothing to correct any of these problems that affect residents and businesses alike. What makes this expenditure even more absurd is the fact that the money expended for the airport sign must come from the City's carryover which has declined precipitously in the last three years. The funds expended on the sign at the Akron-Canton Airport simply accelerate the depletion of North Canton's cushion against

declining revenues and provide nothing tangible in return. Lastly, I would like to point out to everyone that the North Canton Chamber of Commerce already has promotional literature at the Akron-Canton Airport. This is their latest publication which is available to anybody passing through the airport. And I'd like to add you do not have to go through security to get it. To view our sign, you have to be a ticketed passenger, go through security and you see it at the very end of the concourse. I was able to see it the other day but I have to get a armed escort. go through security, take off my shoes and around the corner at the very end of the concourse is this little sign. This is also some additional literature put out by the Chamber. It would seem to me that the sign at the Akron-Canton Airport is a duplication of the Chamber's efforts. In addition, Walsh University also promotes North Canton with its presence in the community. This is one example of their literature that is passed out in their efforts to enroll new students. And they have very nice materials. Again, I think you're duplicating efforts that are already ongoing here in the City. Each of these organizations does an excellent job promoting community development. What North Canton needs is economic development and that will require more than a pretty sign. Thank you.

came up with a list of priorities and what we wanted to approach it with. We came up with a logo, we came up with a theme, we came up with, and if you look at my bulletin board, it's been there for some time, a number of things that we're going to do in addition to the airport sign, promotion material, a economic development pamphlet, some other things that need to be done. We have basically committed \$3,600 a year or less than 10 percent of the money that Council appropriates for professional services in the economic development budget for the airport sign. One of the things that we noted and everybody agreed on is that if you get off a airplane at the Akron-Canton Airport, there's really nothing from North Canton there to greet you. You got quite a bit from Akron and Summit County. You got a little bit from Stark County but you had nothing there to really promote North Canton. So we felt that a sign was important. The locations that we had to chose from one of them was back in the area where you get off a plane and you can see it as oppose to catching it in the hallway or right beside security or somewhere else. We wanted to make sure that we caught people as they got off the planes. It sets next to the Cutler and to the Glenmore Properties signs. So we're in good company. We're trying again to promote our strengths for both the homeowners and businesses. As far as the two businesses that Mr. Osborne mentioned. The first one, I don't have a clue as to what he's talking about because nobody, to my knowledge, has contacted us to try to get help to stay in North Canton that we haven't gotten back to and tried to help. As far as the second one, I got a short list, and I'm not sure that I got all of them, but we took Stark Security out to look at Orion Road property, Blair Cleaners, Credit Union property here on South Main, at a property on Portage, at a property on South Main behind your store Mr. Snyder, underneath there's 11,000 square feet there, we looked at a couple strip malls on South Main. We looked at, or discussed the Schneider Property which was available at the time. The Karlo Funeral Home. We also discussed building a brand new building on Portage because the CRA was just in effect at that point in time and we also showed him Mr. Bourlas's property up on North Main that has some space available to rent. Bottom line, Mr. Watkins, put an offer in on a North Canton property, unfortunately, the owner can not be located by the realtor, a North Canton realtor by the way, and because time was of the essence and he had to get out of his present facility he ended up going to another facility. We're still talking with him about when that lease is up coming back to North Canton. And that's an active conversation as of Saturday, in fact. As far as nothing being available in North Canton, I think that that is definitely wrong. We have at least two properties available on North Main, three properties on South Main, one on Orion Road. We have rental properties available underneath your store on South Main, a couple of them in the strip malls on South Main, one on the North Main strip mall. We have availability on Portage. We have properties that we need to fill in addition we have Washington Square with some vacant properties that we're working on now to try to get additional businesses in out there. This is not pie in the sky. Pie in the sky is not, would be to feel like we're going to bring in another Hoover Company. And that's not what we're looking to do. We're looking to build on our strengths and bring in professional, middle businesses, smaller businesses to try to build on our strengths and get things that fit into the community. The infrastructure items that he's talked about are being addressed. They were addressed in this year's budget. Council knows full well they're in the budget including Mr. Fano's store. So we are addressing those. We're not duplicating what the Chamber is doing. We're trying to augment not only what the Chamber is doing but everybody else. What we talked about in the Communications Committee repeatedly out there is to have a multi media campaign that pulls everybody together. This is not just the City of North Canton. This is going to be Walsh University. This is going to be the Chamber of Commerce. This is going to be the library. This is going to be the schools. It's going to be everybody putting in what we have to offer into a package that we can present to a business or a homeowner to say this is where you want to locate. Not just because you've heard we're good. This is all the reasons why that we're a place to locate. Bottom line is everybody that's looked at this whole program, including committee members that are in, there are a number of committee members here, Walsh University, Chamber of Economic Development Committee, the TAP Committee, council members that have looked at it personally with me have all approved of what we're doing at this point. We're trying to do something positive. I'm trying to, and the Committee's trying to, and as far as I can tell, Council and everybody else is trying to look at the glass half full and trying to figure out how to fill it. Mr. Lane: And once those are done, then this study will address those new figures. Is that what we're waiting on?

Mr. Benekos: Well their developing a hydraulic model and we will use that model then to do our studies based on that.

Mr. Lane: Ok.

Mr. Benekos: So until they get that model done we can't proceed.

Mr. Lane: So we could be another four or five weeks you think?

Mr. Benekos: Correct.

Mr. Lane: Ok. Just need something to return calls with. Thank you.

Mr. Snyder: Member Kiesling?

Mrs. Kiesling: Yes. Just one quick comment I'd like to thank the Administration and fellow council members for our continued support with D.A.R.E. My fifth grade daughter graduated today and it's a pretty neat program. I'm thrilled that we continue to support it and I know quite a few programs are going down around the community and I think it was pretty important for her to be in it. So I want to thank you.

Mr. Snyder: Member Peters?

Mr. Peters: Yea, just a quick comment. I'd like to also applaud the administration. I think we're headed in the right direction with the right attitude. It's about time. So, that's it.

Mr. Snyder: Thank you. My only question, it's ironic, I did receive one phone call from a constituent and now I've suddenly have left the letter they mailed me here. I don't know where they've had problems as you know we've had with all this rain and ice and snow people have had tree limbs falling on power lines. And I don't know that we have any enforcement onto private property for tree limbs and so forth.

Mr. Miller: On private property, no. If it's threatening the right of way we do and we have taken out a couple trees and moved trees out of the right of the way that are impeding the right away. But as far as private property, backyards, that type of thing, we really don't have any enforcement. That's a private property situation.

Mr. Snyder: Because in this one seems to be the house has been vacant for several years and the tree limbs are falling on the person's home. Obviously that must be a civil action, or is that a....

Mr. Pusateri: Oh, yea, for sure.

Mr. Snyder: That would not be a...

Mr. Pusateri: Or it may be an act of God.

Mr. Miller: Although, if you give me the address we'll have Gene take a look at it to see if there's anything else, since it's a vacant house.

Mr. Snyder: As Mr. Lane said, answer the phone calls yesterday, I've given that to the proper departmental authority.

Mr. Snyder: Is there any comment from the, for new business, from the audience?

Mr. Osborne: I'd like to just follow up some of the comments Mr. Miller made. As far as perspective residents moving into the City or professors from Walsh, you do have your Chamber of Commerce. Brokers do have packets. The City has a rich history that's well documented. You're duplicating the efforts of your Chamber. The people that would be moving to North Canton for the most part are going to be small mom and pop businesses. People that are already generally in the area. You're not going to be finding a market from somebody surviving a trip after going through all this security at the airport. You are, there is no way to quantify what you're doing now so everybody can just continue to applaud and say this is great. You'll, I made my points in my presentation. Thank you.

Mr. Snyder: Ya know, I'm sorry, I have to say this because I cannot help but say when it continues to bash the City that I'm elected to represent and I've spent twenty-nine years of my life, I've had a very successful business, I continue, I do pay taxes to the City but last week and the last sever or eight months we've worked very diligently as a Council and as Administration collaboratively with the residents in the area to create the Sanctuary. We've just created two hundred and five homes. Which at the very minimum will generate in excess of \$175,000 in income tax. I don't think that many bodies or there's many municipalities within the state of Ohio that can boast the fact that they just now put in two hundred and five new homes and at a minimum it would be \$185,000 worth of income tax. We've just passed tonight a piece of legislation that will generate 50,000 gallons of water per day on a seven day which is 350,000 gallons at two and a half times our rate. So again, I don't think there's many in our sister municipality to the South our competitors to the West would love to have that business. I don't think anybody in this Administration or this Council is sitting on their laurels applauding the fact that we do have a sign. The sign is not designed to bring people who want to buy an ice cream cone to Swenson's or Handel's or whatever it is. The sign is image. And I've successfully operated a business for over thirty-five years and paid income tax at high rates and I do know what image is. And I will assure you Mr. Osborne when you've done that sir, or when you're ready to go do that, and I appreciate where you're coming from but unfortunately you're in the minority in this one. And I do appreciate your comments but I will say on behalf of my colleagues and I will speak for the Administration, sir, I think you're in the minority. But I do appreciate your comments.

Mr. Osborne: Well Mr. Snyder it kind of alarms me that you continue to build waterlines outside the City when we have water problems, quality problems inside the City for residents that are wide spread. You have fire protections problems throughout the City and you just rapidly just continue to put in waterlines.

Mr. Snyder: Well Mr. Osborne...

Mr. Osborne: And when you can sit here, we meet privately and you tell me things and then you get up here and show me something different.

Mr. Snyder: I don't change, I don't, Mr. Osborne I'm only going to say this here, I'm not in here to get in an argument with you, if this....

Mr. Osborne: Well, I'm not either.

Mr. Snyder: If this, if this town...

Mr. Osborne: Just be sincere...

Mr. Snyder: ...we have a representative of a realtor here, sir, if you're unhappy in North Canton, I'm sure by tomorrow morning you can list your property and move out.

Mr. Osborne: But if you feel one way...

Mr. Snyder: That's that simple. Thank you. I don't want to engage anymore.

Mr. Osborne: ...in a private conversation I don't know it's different when we come up here publicly.

Mr. Snyder: It's not any different, but thank you.
