Ms. Garcia: Hi guys. Kathy Garcia, 1036 Park NE. First of all, I'd like to ask Mr. Lindower if his main problem with the Cingular Tower isn't the kind of contract that you need. You've got a lawyer. If you, if you write out a good contract that tells them if they interfere with anything here in the City, they have to shut that down immediately. That they are notified that that goes. Then you could let the school go ahead and have the money and do it. It takes a little thought but I bet we could do that. The other thing I have on my mind is Mr. Snyder. When you knew that, that Hoover was going to pull out and Julie told you it was a bad idea to buy the

golf course, you decided to go ahead and buy it anyway and put us in debt. And that is very important to you and to the City for open space and to have a nice golf course, ok. Now you have somebody, in Mr. Miller, that has a lot of good expertise. He knows how to handle water problems better than any of you. And when, and when he gives you the expert opinion that you should buy that Crowder property, you pass it off. But then you use his expertise to fix the water problems on the golf course. Now to that, that doesn't make sense to me. I think we could find the money or go in debt for it or whatever and let the future take care of the bill. Ok? And the last thing is, I saw Mr. Fano's letter in the paper tonight. And I think that situation is ridiculous. It's going on forever. You're going to lose another business in the City. And I think we need to get moving and get something done about it. That's all Grandma's got to say.

Mr. Snyder: Thank you. I think Ms. Garcia, one thing so the record's clear. I believe that vote was 6-1 to purchase the golf course. I don't think I unilaterally decided to buy it myself.

Ms. Garcia: Oh Jon, come on. You know very well that you can lead this Council. You're a good horse trainer and a good salesman. So don't kid me.

Mr. Snyder: Well I appreciate your confidence in me. Anybody else wishing to speak to the Council this evening? Please step forward and state your name and address for the record.

Mr. Crowder: Hello, my name is David Crowder. I live at 1665 Markley Street. I realize I'm not a resident of your City but I thank you for taking the time to listen to me this evening. It's my understanding that Council made a decision last week not to purchase the property that we have offered to the City which disappointed me, to say the least. But I guess I just wanted to address a few of the things that I had heard. A couple of them being, well first off just to give you give you history. It really isn't something that just came up. Four years ago we started discussing with the City about purchasing the property to expand the park land. When I purchased that land ten years ago, I bought it with the intended purpose of hanging on to all the property. I have since built my, my home there and the land that I'm looking to sell off is around my home. My feelings were the best use would be park land to not only enhance my own property but the City's as well. Since then when we allowed the City in order to do a hydraulic study, put a well on our property, in order to achieve that hydraulic study. Which worked out very good. The City has since put in a well down there that is producing. A couple of my things that I don't feel were properly, maybe passed on to Council, is I don't know if Council had ever seen the upper Muskingum Echo System Analysis Plan. It was done by Davey Resource Group. I also have several other studies that have been done. Basically, what they're stating is for the whole of Stark County, which includes North Canton, one of the three top resource areas for water is the retention basin in that area. To give you an example, I have a acre and a half lake on my property that I had put in about eight years ago that without fail, other than one time, has been producing 43,000 gallons of water a day in the overflow just from the pressure under ground which is running into the stream and on down. You put that into, to money terms, that's \$72,000 a year and if you take your water source of funding that you would sell water in the City and sell water out of the City, combine the two and figure that up in gallons, that's how I came to that number. I understand you've done some recent contracts that expense water funds, namely for the Airport and for the Aqua Ohio. I think those are great, great things for the City in so much as you're, you're adding people that are going to be using your water. Especially if outside the City, they're going to be paying a higher premium. Now in order to keep that money coming in, it's my opinion that you really need to look at protecting the wellhead areas. Now when you have a wellhead, you've got a recharge area for that and there's a lot of studies out there. If the recharge area is not there, your wells will not produce as well. Without that recharge area, your water table drops and you don't have the availability of it. There were several comments made last week, I apologize I wasn't here, but I did get the tapes of it stating that that land will still be available one, two to fifty years from now. I just want Council, I've worked on this for four years with the City and I really hate to see it not go through. Not only because the City has \$181,000 grant which minimizes the City's output and tax dollars and I understand budgets are very important. We've all got to live by them. But I also realize that a year from now, this property is not going to be available. And I guess just to address some issues, those that have said that nothing can be done out there. I'm a builder by trade. I'm very proud of what I do. I build custom homes. If nobody has been out there, please take the time to stop by my home. We have a 7,600 square foot home that we work with youth groups out of out there. We have a 4,000 foot agricultural building. We put in an acre and a half lake. The last valuation on it was just over \$800,000. And that's pretty good for property that nobody can do anything with. There was a comment the only houses can be built are on stilts. We've built up at Congress Lake. What you do, it's called a helicoil that you run down through silty muck soil, which is what they have up on the east side of Congress Lake. Those houses sit on helicoils. Those houses are selling in the price range of \$750,000 to a million, two. I'm proud to say I built those. We built in Belden Village on helicoils. Most of Belden Village is on helicoils. Now, yes this property is not Belden Village. It's not Congress Lake but it's not going to be there in the future either.

Mrs. Herr: No, we have the million and a half that we're transferring originally which is part of your referendum was to transfer it out of the Income Tax Fund into the General Fund. And then we're borrowing one and a half million now to replenish our carryover so that we can have the funds next year for the Landsdowne Project.

Mr. Osborne: Ok, so I, so you don't have one and a half million in the Capital Improvement Fund right now?

Mrs. Herr: Right now, the money that's in the Capital Improvement Fund has already been appropriated for this year. The Capital Improvement Fund gets funded every year through income tax transfer...

Mr. Osborne: Income tax, right, right.

Mrs. Herr: ...as part of the appropriation ordinance. The money that's, that's in the fund right now has already been appropriated and is, is in the process of being encumbered for projects such as the...

Mrs. Kiesling: 9th Street.

Mrs. Herr: 9th Street and the Knoll Project, so forth.

Mr. Osborne: Ok, so I thought you were encumbering the Capital Improvement Funds in there for Landsdowne now so they'd be available.

Mrs. Herr: No, no.

Mr. Osborne: Ok, ....

Mrs. Herr: We're borrowing the money. We will have it there so that when the time comes, the project, we will have the money at that time, that we can do the whole project in one phase rather than doing it over a period of time.

Mrs. Herr: ...of our income tax revenues. So at least twenty percent but it's much, usually, you know, much more than that. But at a minimum it has to be twenty percent.

Mr. Osborne: So twenty percent of, was it five million we have in income tax collections every year?

Mrs. Herr: About six million.

Mr. Osborne: Six million. So you wouldn't quite have...

Mrs. Herr: So at a minimum it would be 1.2 million.

Mr. Osborne: 1.2 million, right. So you anticipate collecting 1.2 million into the Capital Improvement Fund next year and now you're going to borrow and add an additional million and a half to it for next year?

I know it's not strictly a city issue or a state issue or a county issue but certainly we can do something, please, so we can stop losing our land. We've lost so much. And I didn't come prepared to speak. I was hoping somebody would rescue me and get up and speak before I'd have to. That gentleman that was here earlier, the builder, oh he was so well prepared and so knowledgeable and so terrific and I don't know what to say except, oh please. You know, can't we just get some of those nice cement thingys that are on the highway and put some dirt, that \$12,000 should cover it. Thank you.

Mr. Lane: If I could add to it and Lisa I appreciate you coming by. I know that you talked about this with my predecessor and I know that the State has been out there. I know we've been out there. We looked and did a study and I wish Mike was here tonight and it's probably not fair to paraphrase him but we did a study on the possible removal of that dam upstream from you. And it came back as, as don't remove it. There's no need to at this point in time because taking it down wouldn't affect what's upstream that much. It obviously might affect you downstream. But I know it's an ongoing situation. And Mike's a member of that task force, right Tom? I think whatever the Stark County one is. So I think maybe what we need to do because I don't think, you've never met with Michael yet, have you, with any of the residents?

Mr. Peters: Linda has.

Mr. Peters: Yea, that's a great point. It's not just the loss of land. That sewer line is going to be exposed very soon.

Mayor Rice: Right.

Mr. Snyder: Mrs. Magel?

Mrs. Magel: Kathy Magel, 1025 East Maple Street, North Canton. I have a couple remarks. Number one, I want to congratulate Paul Pusateri for getting his law degree, passing The Bar, and being able to read through Ordinances 13 through 17.

Mr. Lane: ...in microphone and not going...inaudible...I'm telling you. I was doing it through RF.

Mrs. Magel: Well, thank you.

Mr. Snyder: You know Mrs. Herr, one thing I think we should point out since the question was raised, that those funds that we expend for capital improvements are, consist of, we have a levy for street improvement. We have muni levy, muni money, road improvement monies. I think last year we spent about 2.7 didn't we on the '05 budget for capital improvements. And the...

Mrs. Herr: Probably, at least.

Mr. Snyder: ...two previous years we spent a little over 3 million dollars and the action of the Council for the Landsdowne will not increase our expenditure or our debt burden to capital improvement because that project will be budgeted in order to handle it. So that was not a an action to actually increase. That was the thing. I mean, the funds will come up to at least that. We've been very fortunate, we've been able to spend, I know the last four or five years, anywhere from 2.8 to 3.7 million dollars on capital expenditures on the infrastructure of the City which is a significant amount of money with an income a little over 6 million dollars. Any questions? If not, may I have a motion to adjourn?

Mr. Sarbach: I'd like to, before that, just welcome Jan Kennedy to our meeting. Glad this first meeting was a marathon meeting and your welcome to come back for a shorter meeting in the future if you'd like to.
