Mr. Snyder: Chairman Magel.

Mrs. Magel: Yes, this is the third and final reading on authorizing the installation of a traffic light at the intersection of - on Main Street and Wilbur. To be proactive knowing that Swensons is coming in it's already a dangerous intersection as we had spoke and there's going to be in the future even more businesses on both the east side and the west side. So it's ... as the congestion was going to get higher here we were - like to place a traffic light on Main Street and Wilbur.

Mr. Snyder: Any comments of the council?

Mr. Osborne: Mr. President, I'd like to make some comments.

Mr. Snyder: Mr. Osborne.

Mr. Osborne: I've done some further research at the intersection - I'd like to pass it out to the council.

Mr. Snyder: Thank you.

Mr. Osborne: And also I have copies for the press here if you'd - Madam Clerk could you... What I've done here is analyze the 24 accidents that have happened at this intersection and that's over a three year period. These are the number of accidents that have referenced this intersection - 24 accidents did not happen at this intersection. There were only 7 accidents at this intersection in three years - 17 accidents only reference this intersection as the closest reference point. If you look at the second page of the handouts marked page 1, I've listed each accident. January 27, 2000, that one occurred at the intersection, it was a Thursday, the weather was clear dry, it was dark, it was an accident between a full size vehicle and a compact, I have the directions of each of the vehicles, the pre-crash actions as the reports - as reported by the officer, contributing circumstances - in this case it was an injury accident. All the way through on page 1 there you see there were three accidents at the intersection. The fourth accident in July of 2000 is anywhere from 107 to 159 feet from the intersection. You go on over to page 2, none of those 5 accidents occurred at the intersection, running between September of 2000 and December of 2000. Every accident on that page 2 happened anywhere from 266 feet to 530 feet from the intersection. Page 3, we have one that occurred at the intersection and that'd be October of 2001. The other 4 accidents occurred some distance from the intersection. Accident no. 12 in this list of 24, somebody was improperly changing the lanes. No. 14 on page 3 there, again improper lane change. On page 4, accident 15, an 1/8 of a mile from the intersection - two there on that page were at the intersection. Three of those were some distance from the intersection. Page 5, again one accident at the intersection. If you look at the summary page of the citations that were probably issued in these accidents of the 24, 3 were following too closely, 3 improper lane change, 1 was improper backing, 1 was a single car accident - it was undetermined. Of the remaining 16 that were failure to yield, 10 of those were outside the intersection, 6 were failure to yield at the intersection. I haven't analyzed all the other intersections up and down Main this closely, but if you look at the handout, I don't know if anybody brought the bar chart that I passed out two weeks ago, I mean if you want to look at dangerous intersections look at Applegrove and Everhard, which I'm sure everybody would not dispute. Again it's up there and contrary to the trend of all the accidents up and down Main, looks like Everhard has been increasing over the last three years - Applegrove is down slightly. As I pointed out two weeks ago in looking at Main Street accidents, they have declined 171/2 percent over the last three years - that's 2002 as compared to the year 2000. That's a good trend - accidents on Main Street are trending downward. City wide accidents, again 2002 over 2000, they're down 151/2 percent over the last three years. This is all the research I have done on that intersection. We have a court case in Cuyahoga Falls and a court case in Fairlawn. The Fairlawn case the finding was all cities must comply with the uniform code of manual and there was a lot of here say information saying well we thinks it doesn't - that case proved it, it does. The Cuyahoga Falls case was a case regarding the placement of stop signs for the most part, but also included light signals, without warrants or valid warrants. Now I presented letters from the Stark County Engineer's Office and ODOT. They questioned the validity of these warrants - the process in which they were done. The traffic generator form which was used is not the one that they would use if they were studying the traffic history and the proposed history of this intersection or the proposed plans for this intersection. Both of these letters from people that are respected and looked to for traffic analysis. I don't think we can classify this as a dangerous intersection and I really wish council would think about this. In the last six weeks I've heard rumors of a - plans for another light signal on Main Street and I guess it's been publicly discussed here in the last week the city plans yet another light signal on Main Street. Where is this going to end? There are people that are in analyzing situations and make ... assessments who are skilled in this area. I really think there needs to be some long range planning. From Applegrove to Orion really needs to be widened with a turn lane in the middle. There are turnoffs up and down through there and I have almost had rear end accidents myself. You cross Applegrove north bound and the minute you're through the intersection bingo, you have a turnoff going into McDonald's, you have a turnoff going into the BP station or Acme Click, we could rearrange those turnoffs, consolidate some of them - there's more proactive approach to this besides throwing money - As is stated in that uniform manual of traffic control devices, traffic signals are not a cure all, they add to rear end accidents. People will do anything to avoid them - they will take residential streets if they think there's a shortcut to get around light signals. Traffic stops cost drivers wear and tear on their car, increased gas consumption, add to the pollution because of all those stops. I would like further analysis and just as I believe Council Magel - Councilman - Councilperson Marcia Kiesling suggested, let's wait and analyze the situation and get ... more expert analysis of this. Thank you Mr. President.

Mr. Snyder: You're welcome. Not to be - continue to belabor this subject, but predicated on your new theory alone Mr. Osborne, I would say with 6 maybe 7 accidents happening from a left turn and two people being injured and transported to the hospital, I don't think I would want to be the person to say to that person or to their families it's a \$110,000.00 would be better spent on something else if we maimed or lost a body at one of those turns. And again not to belabor, but we do have a certified warrant signed by a certified recognized traffic engineer justifying the traffic signal at Wilbur and Main. Now I realize you dispute that fact - that's okay. And that's all I'd like to say. Any other comment of the council?

Mr. Osborne: Mr. President, I'd like to reply to that.

Mr. Snyder: Please sir.

Mr. Osborne: I do not believe Hammontree was a certified traffic engineer - they are certified engineers.

Mr. Snyder: Well I don't believe it was signed by Hammontree, I think it was signed by a Columbus engineer.

Mr. Benekos: No, it was signed by Hammontree.

Mr. Snyder: Oh, was it? Mr. Benekos: Correct.

Mr. Osborne: Also I'm not trying to down play anyone's misfortune at this intersection. But if you look at every intersection up and down Main Street, Holl Road has comparable accident history to Wilbur. Are we going to put light signals at every intersection? Again there are other avenues. If we have such extreme concern over the traffic moving through our city, I mentioned early on maybe we should look at the speed limit through town.

Mr. Foltz: What's that street by the candy shop there, Jonathan?

Unidentified: Hallum, Hallum.

Mr. Foltz: Hallum. That's where ...inaudible...

Mr. Osborne. North Canton is a very family friendly city. The businesses are all located very close to the roadway. Many of the businesses you step out and you're very close to the traffic flow. Maybe we should think about the speed limit. Again I've talked about spending the money to create a traffic loop so every one of these light signals are talking to each other. Traffic can move through this town without ever having to stop if they were all looped together ...

Mrs. Magel: Mr. President we're off point.

Mr. Osborne: the engineer - the engineer can have all this information right there displayed in his office and control the traffic. If traffic is moving steadily through the city and stopped in a precise queuing fashion there will be breaks in that traffic allowing people to ingress and egress through from the various businesses. I just think this hasn't been thoroughly thought out. And the Mayor continues to insist this is a very dangerous intersection and to be - quite honestly this is - was promised to Swensons and I know that's the case.

Mr. Snyder: Inaudible...

Mr. Osborne: And if the - that's enough I've said enough...inaudible...

Mr. Snyder: I appreciate it.

Mr. Snyder: Chairman McLaughlin, are those scheduled quarterly?

I'm concerned of reports that I've heard that that area was generally used as a dump back at the turn of the century. And another interesting aspect that I discovered this weekend - Saturday we had nice weather -There have been reports that to connect Oster, we would have untold expense making the connection. So I went for a little walk Saturday and I walked from the end of our 24 inch line where it begins there at Everhard and the railroad tracks over there by Belden Village and I walked south to where I was abeam to the Oster property - 1200 paces. Then I walked over here from Bachtel where we ended our 24 inch line last summer - or summer before last I guess now, walked the route that's planned for the installation of that pipe. Again out to East Maple till abeam the property and I was quite surprised myself to find out that it's a longer distance on the proposed pipeline that was to be put in a few - two years ago. I had 1200 paces to connect Oster to our 24 inch pipeline. Walking the Bachtel route out to East Maple I had more than double that - 2800 paces. Now granted if Oster was ever developed we're talking about a boring under the interstate and Everhard Road. But with the installation of that 24 inch line that we put in last year in much haste, we're practically there to Oster. Now this council promised that we would thoroughly investigate the Oster property. I really think that's what we should be doing now make a comparison in quantity and quality of water. As I've showed this council on the ODNR maps, the Oster property is located in one of the highest producing areas of water in this entire county. So I'd like to put to rest the rumor that we're talking multi many millions to go down and connect to Oster - that is not true.

Mr. McLaughlin: Mr. President, we are getting out of order. I mean that...

Mrs. Magel: Off point.

Mr. McLaughlin: We're getting really off point on what the legislation of Ordinance 41-03 was ...

Mr. Osborne: Point of order, I think I have the floor Mr. McLaughlin.

Mrs. Magel: Inaudible...

Mr. Osborne: I disagree. Everyone keeps saying we're wandering off. We need to look at the big picture - all the facts. You just don't look at a single issue. So I present them to the best I can. And council can approve the - can set there and just say we're going to ignore all the research and the factual information I've presented. And that's all I can do.

An ordinance authorizing the extension of an eight (8") inch waterline North on Windem Avenue from Carlton Street to a proposed cul-de-sac, a distance of approximately 262 feet and the extension of a six (6") inch waterline from the proposed cul-de-sac to the developer's north property line, a distance of approximately 276 feet; located in the Northwest Quarter of Section 5, Plain Township (Angel's Pond), in accordance with plans and specifications approved by the North Canton City Engineer, and declaring the same to be an emergency.

Mr. McLaughlin: Yea, we're looking at 262 foot of 8 inch pipe and 276 inch or 76 foot of 6 inch pipe. There's four single family dwellings going in there, anticipated to be 400 gallons per day each, so it's giving us a total of 1600 gallons per day of new water source.

Mr. Snyder: Any comment of council?

Mr. Osborne: Mr. President, may I speak?

Mr. Snyder: Mr. Osborne, please.

Mr. Osborne: I will have to admit I haven't really researched this. Mr. McLaughlin, you say there's - this is going to be servicing four...

Mr. McLaughlin: inaudible...permit. Yea the water extension request that we had last week it says on here demand is four single family dwellings at 400 GPD each.

Mr. Snyder: Mr. Vukovich originally applied I think originally sometime in '98 to develop that whole region with water and then it was granted to the annexation of that area, we extended water, we annexed the other portion of the area. At this present time he's only requesting the four corner lots I think in that development which he controls. And of course the lines will be at his expense, the hookup is at his expense.

Mr. Osborne: Okay.

Mr. Snyder: And it's billed at I think now we're about 2.3 or 2.2½ the out - the inside rate. And the outside rate has dropped a little under our last time we changed, but it's about somewhere between 2.2 and 2.3 of the inside rate. But he was responsible for the service from our main running down there, which we have a main I think looped at the corner and it will connect onto the corner of that's Orion and - what is that street that runs down there...

Mr. Lindower: That's Burkey.

Mr. Benekos: Well this is on the east side of Cleveland Avenue. It's up...

Ordinance No. 43-03 - First Reading

An ordinance providing for the issuance and sale of \$1,000,000 notes, in anticipation of the issuance of bonds, for the purpose of paying costs of improving and expanding the municipal waterworks system by constructing and installing waterlines, together with all necessary appurtenances thereto, and declaring an emergency.

Mr. Snyder: May I read into the record so it's noted that attached to this particular ordinance, 43-03, is a Certificate of the Fiscal Officer of the City of North Canton, Mrs. Julie Herr, stating that we are - the estimated life of the bonds and that we are in a position to sell such bonds. This is to pay for the notes that we have out there on that - those short term notes for that 24 inch waterline that we did put in last Spring I think or the Spring before - some time ago the one there on Everhard connecting us to the City of Canton water. Is there any questions on that?

Mr. Osborne: Mr. President, may I make a statement?

Mr. Snyder: Please sir, go ahead.

Mr. Osborne: I am remiss I didn't bring my pictures, but this is the 24 inch waterline that runs from Everhard Road north up the railroad track and terminates some distance from the water treatment plant. It's not actually hooked up to the water treatment plant at this time. So I think the public needs to understand that. In the event this waterline was needed, two 6 inch fire hoses would have to be hooked up to two outlets that stick up out of the ground and water would be transported the remaining several hundred feet to the water plant in that manner. And as I understand it it will not be plumbed into the actual plant until the upgrade of the water treatment plant. And as I pointed out before on a couple of occasions, due to the way the water would be pouring into this water treatment plant, generates a lot of air bubbles and in the process air locks the water treatment plant. Now the water treatment plant has to be back flushed as I understand it about every four days. Trying to run water into this plant through these two 6 inch hoses that finish that 24 inch line connection, the water has to run very slowly otherwise it ... exasperates the water - the air problem in the water.

Mr. Snyder: Exacerbates. Mr. Osborne: Thank you sir. Mr. Snyder: No problem.

Mr. Osborne: Inaudible...mouth - dry mouth tonight. Consequently, these - this 24 inch waterline will not provide a backup water source if the city were to be in a severe drought or lose a well. So let's keep our fingers crossed that we don't have to use this - these two 6 inch fire hoses. And I wished I had my pictures I - but if you drive down there on the north end of the property you can see two 6 inch white lines terminating right there north of the water treatment plant and that's where your 1.2 million dollars ends.

Mr. Snyder: Contrary to a lot of people's belief, the Administration as well as the Council of the City of North Canton, does have at the best interest of the citizens - it would be fiscally irresponsible today to connect those pipes into the Water Treatment Plant when we begin to do the expansion and the enlargement of that plant. However, most people say well you fixed my road today, you dug it up tomorrow. Well we don't practice that. Even though it's not a 100 percent the best way to do it, the administration as well as the council, the majority of the council, feels it's fiscally responsible and it would be very irresponsible to do otherwise. And that is the reason for the two hookups - the makeshift hookup that we have today. Mayor, am I correct on that?

Mayor Rice: Exactly Jon. It's - I've sat already tonight and heard so many false statements I hate to - if I commented on every one of them we'd be here all night long and I know these students don't want to be here all night long. But once again that's a - that line was put in for an emergency water supply to the water treatment plant, which in fact has been successfully completed. We didn't have a problem last summer, we won't have a problem this summer. It will serve the purpose we need to secure the water supply for the residents of this city now and in the future when it's permanently hooked up. And again as we talked about a long time ago, we felt it fiscally irresponsible to go to the expense of a permanent hook-in that would just have to be removed at a later date. So again people are - one person in particular continues to want to twist the facts around to be self-serving. But the fact of the matter is the intention of that line you know it's a little funny now, the person that was protesting in front of City Hall against that line now wants to use it to hookup Oster - that's very convenient. But the fact of the matter is the line's there. I think - I don't want to waste a lot of time cause I think the vast majority of people here at City Council understand what we did, why we did it and it's all been done to serve the best interest of the citizens. It's successfully accomplished it's goal and will continue to do so.

Mr. Osborne: Mr. President, may I speak?

Mr. Snyder: Please, Mr. Osborne.

Mr. Osborne: Okay, I very much concur with your statements Mr. President and the Mayor's. Financially it is more prudent to hook it up when the expansion of the water treatment plant is completed. But I do not concur that it needed to be put in an emergency and it will - contrary to the Mayor's statements, it will not accomplish its purpose that it was - when the council voted on this funding. And yes I'm willing to use that line now because we have used 1.2 million dollars of the public's money. I'm not going to be illogical or spiteful and say well just because I was against it then I'm going not utilize that asset. It's in there now, we've spent the 1.2 million dollars. It terminates short of the water treatment plant and about all the water you can get through it is maybe enough to keep your yard green around the water treatment plant cause it will not supply the water needs the city would need if you lost a well or had a severe drought.

Mayor Rice: Jon, I'd just reiterate again, we're listening to flat out false statements. But I don't want to debate this all night long, I think most of the council understands that. Hopefully the public understands that that those are - that's just flat out a false statement, there's no other way I can characterize it.

Mr. McLaughlin: Well I think also to add one...

Mayor Rice: To sit here and think that a 24 inch waterline coming up hooked up to the City of Canton is only going to produce enough water to water your lawn is absolute irresponsible to make that statement. But that's flat out false and I also think it's off the point of the legislation but ...

Mr. McLaughlin: Mayor, one of the questions I - or comment I'd like to make was, when we put that line in we weren't sure where we were going with Dressler. Dressler was still an unknown element if I'm not mistaken. Am I right or am I wrong? We weren't sure if that was going to be continued...

Mr. McLaughlin: We were still in the development stage or seeing where we were at - it was a hot summer. There's no doubt in my mind we did the right thing. I mean there's - we had to have something - some type of relief. The year before we had a watering ban on and as far as I'm concerned it was well spent.

I don't know if these people can't read or whatever, but I'd like to see a sign that says hey stupid stop here you know. But it is causing a problem. No not me. I caught my wife once and said nah. It is it's a major problem because you've got those people coming off Main, they're turning right or left onto Schneider and they want to turn in there and then it's a bottleneck at that intersection. Where if those people would of stopped before the drive it would of been no problem. But it's just ...

I'm also disappointed that I didn't find out about the Law Director's ruling until Saturday when I picked up my packet. It's kind of sad that we're held up here for two months possibly cause we have to wait for secretarial services. So I'm just keeping my fingers crossed that we get this in under the two months and we could possibly get this zoning passed before our summer break. And I also hope that the council will live up to its word and we can start discussing the PRD prior to May. Second item - I was looking through past minutes here recently and in the minutes of May 28, 2002 council meeting, Mr. Roy Batista, the Law Director, made a suggestion that subsequent to the annexation of Oakshire into the City of North Canton that he would suggest the renaming of Cleveland Avenue to North Main Street. I don't know - I don't recall any legislation doing that and that was his suggestion. So if you want to double check the minutes that are so well preserved by our Clerk of Council, I would suggest that. And I guess that would fall under your committee Mrs. Magel. That's the recommendation of the Law Director. Last item, I'd like to read this letter. In the last several weeks I have made both a verbal and written request to the Clerk of Council for digital copies of past council minutes and agendas that I believed were being archived for future use. I was informed that these files are being routinely destroyed soon after the minutes are transcribed verbatim and a hard copy is printed for a permanent record. The routine destruction of electronic files that take many labor hours to create and that have a potential for use in many ways is not a practice that should continue. I would request that as President of City Council, Mr. Snyder, that you direct that the destruction of these electronic files in the Council Office, especially verbatim transcripts of council minutes be halted immediately and that council implement guidelines for the archival process of all electronic documents. I make this request for several reasons. First the creation of electronic documents in the course of city business requires the expenditure of city funds. This is especially true in the verbatim transcription of council minutes. Electronic copies of city documents are valuable city assets and disposal of these assets deserves no less scrutiny than the disposal of any other asset owned by the city. Second the electronic format of

these documents has great value for many uses in the future. One of the uses of maintaining electronic copies of council minutes and agendas is that they can be posted on a city web site for access by city residents at some point in the future. An example of this practice can be seen at Canton's municipal web site and I list the web site address, where council minutes posted in an electronic format date back to December of 2000. Jackson Township's web site and I list their address as well, has council minutes posted, they go back to September of 2000. Massillon and I've got their web site here as well, has council minutes posted on its web site that go back to January of 2001. Plain Township's web site, also their web site listed, has council minutes that go back to August of 2002. In a conversation with Plain Township's clerk I was told that most research of past council business is done via links to archived electronic files of council minutes and agendas. Finally the archival use of electronic documents such as council minutes and agendas would allow the city to reproduce these documents on request at little or no cost to the city. One could simply send the attached file to a resident in an email or copy the file to a removable media supplied by the individual requesting the file. The file could be archived as a read only file if there were concerns that the file might be altered. This would allow for wider distribution of information to the public, more efficient use of public monies and improved services from the city for the citizens of North Canton. And that's all I have.

Mr. Snyder: I appreciate that. Allow me to answer a couple of your questions. Number one - relative to Mr. Batista's opinion, he was not asked to give that opinion until Thursday afternoon, which he did and it was put into the packet as of 3:00 Friday. Unfortunately you did not pick it up until Saturday, but the opinion - I did have pursuant that I did have discussion with Mr. Batista regarding that. It would be very tenuous to say the least and I'm sure Mr. Treadon will back me up, for us and I apologize for my statement to you last week regarding that. But Mr. Batista's -- in his legal opinion to me, for us to vote upon something that is not completely written and documented would be asking for a possibility - as some people challenge the actions of council before it could be done it could be challenged. So consequently I made the decision as your president and I hope that you - I guess it's easier to ask for forgiveness than it is to go ahead and do it. So I'm asking - I did tell him that I would feel more comfortable with moving along that line. So that is the reason. I'm sorry you're inconvenienced on that, but - And relative to your electronic files, I believe that letter was originally addressed to myself or to the clerk, I don't recall. The Clerk, myself, Director of Law Batista did meet relative to electronic capture of data and transmissions. And it's our feeling, the three of us, and I realize as you know yourself Mr. Osborne, I'm not very computer literate - I like to count my own money, I like to feel it, I like to touch it. I'm 56 years old and as long as I am the president of council I apologize to my colleagues, but we will not capture that data electronically. However, I did have a discussion with the Director of Finance relative to transmitting the documents on the web site and she is at this point I believe checking on that with the people that do it. So we are pursuing along those lines. I hope that somewhat answers your question. I'm not saying that to be flippant or to be argumentative, but that's the decision that was made. And that can be relooked at again this December after the election depending on who's sitting in this chair at that time. But I apologize sir, that's the reason for that. Although I did take into consideration some things. It actually becomes very burdensome upon the Assistant Clerk to do it that way. Transmitting it on the computer is very simple and we will do that, but we will not capture on electronic disks and disseminate according. And the actual cost of dissemination of any document upon request of the open records law is paid by the person requesting that document. So there's no cost to the city. Is there any other questions ...inaudible...

Mr. Osborne: Mr. President...

Mr. Snyder: Sir.

Mr. Osborne: May I speak?

Mr. Snyder: Please.

Mr. Osborne: Well I understand Mr. Batista's ruling and I had already quite actually anticipated. I knew all the slashing and burning of that code could easily result in that. In fact I even questioned if we shouldn't send it back to the Planning Commission. That's why I was trying to caution council that close review of that proposed zoning had been gone over line by line by the previous chairman, Mrs. Magel-very close scrutiny for two years and I just couldn't understand why suddenly there had to be deletions to the extent that were made. I guess I have to ask you where - there's no way we could have two readings like we had talked about and then - in fact I'd even - I had even proposed that that we have two readings and then we, if it's not back from D.B. Hartt we'll table it until we have the final form. Has that been discussed at all?

Mr. Snyder: Yes sir. Maybe I can possibly offer somewhat of a solution not knowing the answer. But if you will be so kind sir as to contact D.B. Hartt, not engage them, but contact them and possibly by next Monday see if there's some way that you may accelerate the capture of that data on disk that it could be printed out, that we actually have the document to be attached to the ordinance - that's the problem. It could - we possibly could do it, we'd have not problem. Should someone challenge it, it gives them standing to challenge our ruling in court. Am I saying that correctly when I say...

Mr. Treadon: Well I don't - I think it's a pretty practical matter, if you don't have the document you're intending to pass, you're voting on something that you don't know what it says, I think it's subject to challenge.

Mr. Snyder: And possibly there's someway if you would pray upon her our situation. We were very good customers, we paid timely and the next time we redo this you may - she may not want to get involved, but I don't know. She possibly might be on retirement by then. But you might ask her that question and see if there's someway and I will ask that question of the Law Director. Unfortunately I will not do that until Thursday, but I promise you an answer back by Friday morning. And - but if that would help you, we will do anything as a council to expedite your committee to get that report out. I realize how you want to get that out for several reasons. From the impact of the zoning versus certain situations that are transpiring in the city and I think we're all aware of that and all worried with you along with that. But if you'd be so kind to do that maybe there's someway that we can expedite it and move along that line. If that will help your cause I would offer you that. I don't know - I don't know - I'm not you know you'll have to make that decision.

Mr. Osborne: May I respond sir?

Mr. Snyder: Please.

Mr. Osborne: Well I concur with Mr. Batista's judgement. I ...inaudible... like I said feared that was going to be the case and a - So I will take your suggestion up and talk with Mr. Hemminger first and maybe I would let him contract them.

Mr. Snyder: That's fine.

Mr. Osborne: I would like to follow up on your other comment sir...

Mr. Snyder: Please.

Mr. Osborne: that the letter is addressed to you, Mr. Snyder, concerning...

Mr. Snyder: What was the reference date on that?

Mr. Osborne: That is - just today.

Mr. Snyder: Oh I apologize then I didn't see that.

Mr. Osborne: Yes.

Mr. Snyder: That must be the ESP... Mr. Osborne: I have copies here...

Mr. Snyder: I knew I was going to get zinged. I just didn't know how. I was...

Mr. Osborne: I don't know if you totally grasp the situation here. We spend almost two weeks of a clerk's time converting this to a electronic format.

Mr. Snyder: I'm ...

Mr. Osborne: So it's already put into electronic format. I don't know why you would destroy that after you print out one hard copy.

Mr. Snyder: My apologizes sir, I was thinking of the letter that was addressed to Clerk Bittle that I read relative to transmitting on ... I apologize I was - I wonder if I may impose on you to allow me to read that letter and possibly Tuesday or Wednesday I will contact you and you and I can discuss it and you can explain it and hold my hand and...

Mr. Osborne: Actually this is the original.

Mr. Snyder: let me know a little more what it's about. If you'd be so kind to do that. And then you and I will have a conversation which we'll return and we'll bring to the council floor next week. Will you be you're fine with that and you...

Mr. Osborne: Well can I just elaborate here a little bit more?

Mr. Snyder: Please, go ahead.

Mr. Osborne: This is in no way a reflection on our Clerk of Council - she does a very excellent job. But these are past practices that had just maintained their momentum. I have talked to several municipalities in the area, no one is destroying their electronic versions of the material. The concerns the Clerk has had is that, number one, there's no room for storage. I think if someone could offer some IT expertise this could be totally eliminated. You could probably put 5 years worth of minutes and agendas on one zip disk. A zip drive can be installed in any or both - any computer for \$150.00. And as I've showed, every municipality around us is posting their minutes online. But if you've already destroyed them you have no history there to post. Our Clerk is spending two weeks transcribing this into a word document, that's got to cost a thousand dollars. Why would you destroy what you just spent two weeks creating. So I really would appreciate and I thank you for offering to read it closely and wanting to discuss this and if need be you can consult with your IT experts where ever you want...
