What'd I like to do is take the opportunity to build on the momentum and excitement that was built last week by Rich Jusseaume and actually since this past summer. And representing one of the committees that was a spin-off of the Imagine North Canton initiative and then also talk about how that committee interacted or interfaced with two other committees that are active here in North Canton. The committee I'm talking about is the, it's called the Vital and Vibrant Commercial Environment Committee. That was a committee as a result of the Imagine North Canton. That committee has been active since

around August of last year and it has members and you're going to see a little bit of similarities between these three committees but the members on that committee are community leaders, organizational leaders, educators, residents, business owners. That's the committee makeup. It's a very diverse, broad committee. It has, has a mission similar to another committee I'm gonna talk about. And that's to develop initiatives and focus and direction to stimulate and help the economic well being of North Canton. What I'd like to talk about are the two committees that that committee interfaced with most recently and those are TAP, Talk About Potential, if I get that correct. And the other one is the North Canton Chamber of Commerce Economic Development Committee. And just for those who may not be aware, the TAP Committee consists of approximately twenty-five North Canton residents and the easiest way for me is just to kinda read this paragraph that was put together for me. But it consists of about twenty-five North Canton residents, business owners, organizational leaders and it's been meeting regularly for about the past fifteen years. The purpose is to identify community needs and to promote solutions to those needs through cooperation and collective influence. The goal of TAP is to enhance the quality of life of the residents and businesses of North Canton. That committee, along with the North Canton Chamber of Commerce Economic Development Committee, which is an active committee led through the North Canton Chamber, and its members include, again, North Canton residents, business owners, community leaders, educators, and likes. Its mission is to develop and implement plans that stimulate the economic well being and growth of North Canton. What had happened was this Vital and Vibrant Commercial Environment Committee had been meeting regularly as a result of the Imagine North Canton and they felt that they were developing initiatives that were parallel to some of these other committee's efforts. So what we did was, we had a three committee meeting about somewhere mid-February where TAP, the Economic Development and what I'll call the VVCE, Vital and Vibrant Commercial Environment Committee, got together and discussed, you know, where these three committees fit within the community and what their purposes are. We met, we decided to, for the three committees to develop their top initiatives or top priorities that they believe should be pursued by the North Canton community. And the committees separated and we reconvened about a month later which was last Thursday with the results of those votes. Two things came out of that last meeting. One, the VVCE Committee is now dissolved. It has been really taken up by the Economic Development Committee. There was no need to have two committees working on the same initiatives burning up resources. So the Economic Development Committee now has taken over those priorities and initiatives from the VVCE. The other thing that came out of that is the list that's on the handout that I gave you and we have some extras if folks in the audience would want those. But we came out with the top initiatives that these committees would like to see pursued and I'll kinda read what, what we have here. These are suggested priorities. You'll see that they're extremely consistent and the committee members, the three committee members would like City Council and Administration to use these lists as appropriate, as you feel appropriate to guide future short and long term economic decision making efforts. So I'll just quickly read these three lists. And what you'll notice is the similarities among the lists. Again, these were done in separate meetings through voting and discussion techniques but they are very similar. TAP had eleven initiatives on their list. The top was, they would like to see a full time economic development director. The next one on their list, number 2, was land banking city funding for the CIC. Third was down town parking. Fourth, post office. Fifth, community sign. Sixth, to work on annexation. Seventh, Hoover/Maytag front lawn. Retain that green space across the street. Eighth was to promote Walsh as a community asset. Ninth was to work on usage of the Fairways which use to be Arrowhead Golf Course/Country Club. Tenth was to retain, work to retain current businesses such as Hoover. And eleventh, complete the Main Street improvements. So I'll just quickly go through the Economic Development Committee's list of priorities and then the VVCE's. And you'll see the top one on the Economic Development Committee was funding and effective use of North Canton CIC. That was second on the list for TAP. Second on the list for Economic Development Committee was to hire an economic development director, first on the list for TAP. Third, down town parking. Third on the list for TAP. Fourth, community sign. Fifth on the list for TAP. Vital and Vibrant Commercial Environment Committee's first on the list was to hire an economic development director. Again that was the top two for the other committees. Within that broken down was to create, manage, or I'm sorry, create and manage a land bank group, the CIC. Second on their list was, develop and provide a competitive package and incentives to keep, retain current business and to stimulate new business. Third was quality professionally written city development plan. Fourth, work with Maytag to explore options for Hoover as things progress there. Fifth was to develop an economic development plan. Sixth, attract employers that employ high wage earners. Seventh, an SID, Special Improvement District. And Eighth, expand parking. Again, I'm just kinda delivering the message. Those three committees that are now two, TAP and Economic Development Committees, are very active. There are members in the audience and certainly most of you know how to get a hold of those members. But there's meat, more meat behind these lists. These items on this list. This is a list I gave you but they have action plans, timelines, responsibilities and people that they would like to work on these. So there's more behind it should you need that or want that. And that's the end of my presentation. I appreciate the time and hope that this is of some value and will be used appropriate. Thank you.

Mr. Snyder: Thank you sir for your kind remarks. It seems like, just to cursory review this. There's a lot of work and a lot of effort went into that for, to which the, on behalf of the Council, we appreciate your efforts and I'm sure the Administration will move accordingly with that. Thank you. Is there anyone else wishing to speak to the Council this evening?

Mr. Dansizen: My name is Jim Dansizen. 3645 Dauphin Drive, NE in North Canton. I'm a member of the North Canton Chamber Economic Development Committee. A member of TAP, Talk About Potential for North Canton and the Walsh University's Imagine North Canton. A great many men and women have spent many hours, days, months and years on these committees. Men and women from all walks of life. People from the political arena, business community, and every day ordinary citizens who are interested in the future of North Canton, Ohio. I believe that we have a City Council and a City Administration that is ready to move this City forward with some of the issues that Rod talked about a minute ago. Namely, an economic development director and a proper funding of the CIC. TAP has been working for many years on these and other issues. And now we can see some light at the end of the tunnel. I'm pleading with you City Council, City Administrators, please make our dream a reality. Thank you.

Mr. Snyder: Thank you sir. Anyone else wishing to speak to the Council this evening? Sir.

Mr. Saylor: My name is Glenn Saylor, Jr. I reside at 340 Reed Avenue, North Canton, Ohio. I've come tonight to support Councilwoman Kiesling's suggestion of hiring an outside consultant to create a formal economic development plan for the City of North Canton. This needs to happen before a community improvement corporation is established not after. Some have said that spending fifty thousand dollars to have a consultant develop such a plan is a lot of money and I would not disagree. But when we were talking about appropriating two million dollars to fund a CIC, fifty thousand dollars represents just 2.5 percent of that amount. There's no guarantee of success whatever we do but you certainly increase your likelihood of success with a formalized plan. Mayor Rice says that we don't need to hire an outsider. Although I respect and appreciate the efforts put forth by the citizens and local groups, each one of us, including myself, come with our own biases, our own prejudices, and our own economic and political interests. Some times we are too close to the trees to see the forest. We are too close to see things and we may overlook positive things in the City of North Canton and likewise we may overlook some of the negative things. It is important that this be balanced with an outside entity that has none of these biases or prejudices. An outside consultant who has experience working with many communities throughout the United States is going to be able to help us see the many positive aspects of this community and just as importantly, the not so positive aspects. I am sure that they will very much want to hear the ideas of the citizens of North Canton and meld these into the economic development plan. If economic development in the City of North Canton is to be successful, we will need to entice outsiders to invest in this City. Therefore, we need to have a formal economic development plan that honestly looks at North Canton from an outsiders point of view. Some have said that the sky is falling and we must act now. I would suggest that we take the six months required to develop a formal economic development plan. This will put us in position to create a CIC if that is the direction we decide to go late this year or early next year. This extra time up front may put us years ahead in the long run. If what I have said so far has not convinced you that developing a formal economic development plan is a good idea, than I conclude with this sentence from the March 16th edition of the Canton Repository, quote, City Administrator, Michael Miller, who was the, who was a member of the Canton CIC Board for twelve years noted that Canton didn't have formalized economic development plan when he was part of the board. Now I think Mr. Miller was arguing that we don't need to have a formalized economic development plan to be successful. But I think if you took a long hard look at our neighbors to the south, the City of Canton, you'll agree, we do need to have one. Thank you.

#### Ordinance No. 52-05 - Second Reading

An ordinance to approve, adopt, and enact the 2004 Residential Code of Ohio for One-, Twoand Three-Family Dwellings, and subsequent editions or amendments as may hereinafter be adopted and promulgated by the International Code Council and the Ohio Building Officials Association for the City of North Canton, Ohio, together with all changes, amendments, and revisions thereto and incorporated herein as "Attachment A," save and except such portions as are hereinafter deleted, amended, or modified by these Regulations, are regulating the fabrication, erection, construction, enlargement, alteration, repair, location, and use of detached one-, two- and three-family dwellings, their appurtenances and accessory structures in the jurisdiction of the City of North Canton, Ohio; and providing for the issuance of permits therefore providing penalties for the violation thereof, and repealing all ordinances and parts of ordinances in conflict therewith, with the exception of Appendix B, C and D of the North Canton Building Code.

Mr. Snyder: Chairman Peters?

Mr. Peters: Uh yea. Just one question Jon. This has nothing to do with the area behind City Hall ...inaudible.

Mr. Snyder: No, this is a, this just simply is bringing the enforcement, our code, to be uniform with the Ohio Residential Building Codes.

Mr. Peters: Ok.

Mr. Snyder: I think we were in conflict with the two. Now they are both harmonious and the laws of the State of Ohio are mirrored to, or the City of North Canton laws are mirrored to the laws of Ohio. At the present time, I believe, we go back maybe almost twenty years since...

Mr. Lane: I think it's eighty, eighty-five.

Mr. Snyder: Yea, since we've actually changed anything. So they're just asking for enforcement purposes that local people who have to abide by those rules know because it's a uniform no matter where you go to do that, it's all the same. And ours would be identical. But no, it doesn't have nothing to do with changing the...

Mr. Peters: Ok.

Mr. Snyder: ...zoning and, coming up.

Mr. Peters: So this just basically brings up to date with...

Mr. Snyder: This will bring our, the enforcement and our codes uniform with the Ohio Building Codes.

So by raising these rates, in essence, the renter will be paying the appropriate fees for not only the physical facility but the personnel that supports the rental. I guess my big question would be is, why the delay on this, initiating this legislation? If you continue to delay this legislation we will not have this vital economic tool available to us until at least June or July now. If summer break intercedes, which we enter into, I believe in mid-July could mean waiting until September or later to get this CIC tool available to us. The public supports this plan and idea. And in fact you saw tonight all three sub committees of the community has it as one of their priorities. I think that speaks volumes as to the mood of the people in our community that we all represent. All we need now is for City Council to take action. We don't need any further delays. In an effort to work with this Council due to the lack of a full membership tonight and my efforts to be as patient as humanly possible. Which is not always the easiest thing. I will not introduce this legislation tonight; however, I would request that City Council place the issue of funding the CIC on the agenda again next week and introduce legislation in two weeks for a vote on funding the CIC for two million dollars. If at that time, over the next two weeks Council still does not see fit to submit this legislation for a vote, it is my intention at that time to introduce the legislation. In summary simply, and I think you heard it tonight, if you've been listening. You've been hearing it for quite some time. The people in this town want and expect the City government to move the City of North Canton forward. We need to make a decision on this important issue. That's all.

Mr. Snyder: Mayor may I just say one thing. I appreciate your diligence and your patience in this effort. However, I will assume full responsibility as you know it rests with me as to whether the agenda item is and what it isn't and as chairman of also Finance, I'm very cautious as to move ahead. And be it right or be it wrong, that's my nature. I think that's within my privilege. I will tell you it was of my intention all along, Chairman Kiesling of Economic Development has no standing to either place or not place it on the agenda. It was my intention all along to have it next Monday evening. However, I will say to you sir at this time, it'll be open for full discussion. I cannot sit here and promise you that you will in fact get two million dollars. However, it will be discussed fully and openly with all members of Council and, and I appreciate, as I say, I appreciate your patience. And I understand that you need it. It's a vital tool. As you know, I don't think a member of this Council does not support the thought of a CIC. However, we are, at this point, we're undivided as to the amount. And again, even if Director Herr is not here, we all know where our finances are. But we will, sir, move it ahead and hopefully bring it within the next couple weeks to a vote. But because as, longer you wait, I realize, that you're loosing valuable time but I appreciate your kind remarks. Thank you.

Mayor Rice: That's fair enough.

Mr. Sarbach: Yes, Mr. Mayor, we, as I discussed at our meeting a week ago that I am in support of the CIC concept. And some of the, two of things we discussed, one changing the makeup of the personnel of the CIC, I don't see that being done yet. Hopefully, that can be done or relayed to us before that time or by that time. And the second thing is, I'm, we're flux about what our unencumbered carryover is. It makes a big difference in my vote if we have, like you suggested, a fifteen million dollar unencumbered carryover or whether we have something less than eight or seven. That makes a big difference to me simply because of what it does to the complexion of the rest of our finances and our notes and our bond rates. Of which I know little about, but I know people who do know about it. So, those are my concerns. If we can get to a comfort zone in there, I'll give you my support. But until then, I'm very cautious on this. But the concept, I think, is great. And I think we need to do, move forward on it. Also we need to move forward on an economic development director. That was funded over a year ago. I don't know where that standing is, I haven't heard what the search has developed, if anything. We haven't had any reports on that but that has already been, at least from this side of the table, been, been funded. If you need more funding, it hasn't been asked for or I don't know where you're at in that search. So maybe that could part of an upgrade as a companion issue to the CIC.

Mayor Rice: That's, appreciate your, your point. And I don't begrudge anyone's opinion on this. My point is, simply, we need to do something. We need to make a decision.

Mr. Sarbach: Well, I'm, I'm hesitant....

Mayor Rice: For example, we have, and whether you, you know, I firmly believe two million or awful doggone close to it, is essential to do it. A half a million dollars, quite honestly, you're going to defeat the purpose of what we're trying to accomplish. Because you can't do much with it and I think we talked about that Greg.

Mr. Sarbach: Yea, that's good.

Mayor Rice: But to finish real quick. So, but we need to find where we can go. And what we can work with. The Administration is open. We always have been open. I'll fight to keep it as close to two million dollars as we can. But I understand Council's concern. The point is, and

as Mike can tell you, we're working on more of our marketing tools. Many of you have probably seen it. If you haven't, stop in, Mike will share it with you. The brochure we're doing on what are the incentives that the City has to offer to new businesses. We can't complete that until we get an answer on the CIC. Because we got to put in there whether we have the CIC or we don't have the CIC. Ok? So it does affect other things and it is holding up other issues. All I'm saying, I think we owe it to the community and we owe it to the City and our efforts of economic development to make a determination to what level are we going to fund the CIC. And I understand everybody said yea, we like the CIC, we've had it. The issue is, are we going to fund it adequately or not to be effective. So that's the decision we need to make. And I just think we need to make that decision. I don't think that's that difficult of a decision that we can't sit down, hammer something out and decide what it is we want to do. That's all I'm asking for, a decision. Yea or nay. But I think we need to know where we need, our direction and our ability to be ... we're talking to people what things do we have to offer, what don't we have to offer to people.

Mr. Sarbach: I think we all agree on the concept. My concern is, I don't have to vote it down because it's a good thing. And if, if we don't have, if we're not all in a comfort zone, I'm afraid it could be voted down. As far as the amount of the funding, I'm willing tonight to give you everything over our documented unencumbered carryover of ten million dollars. Anything over that, I'll put in the CIC. So if the fact there's fifteen million there, I'm in favor of funding it for five million, rather two. I don't think that's the case. I don't know what the actual carryover is.

Mayor Rice: Inaudible...check, I might take that. I think Julie's wincing over here. I'm not so sure.

Mrs. Herr: Unencumbered, there's a difference.

Mr. Snyder: I only want to caution Mr. Sarbach this is an election year, sir. I don't think the people will appreciate paying three percent income tax come January 1.

Mayor Rice: Is the tape on. Do we have that documented.

Mr. Sarbach: I'm saying, I don't believe our unencumbered carryover is at that point. That's what I'm getting at.

Mr. Snyder: I agree.

Mr. Sarbach: And those are the numbers we were using so, but, yes it's important and I don't have to, I want to, I don't have to be completely comfortable with it because we do have to take some risks with this as we all know. But I like to have some of these things covered.

Mr. Snyder: Mr. Mayor, if I may state since we are at this point. It's really out of order but I do know that your intentions are, as I was communicated to be by, I think, Member Kiesling, that your meeting with your CIC Board next Monday in a brief decision to possibly begin your restructure. I would only ask, sir, that you know, I realize in a fifteen or twenty minute meeting you're not prepared to announce whom you want or what you want. Possibly the numbers would be very nice if you knew the total aggregate amount. How many people would be on the Board. Another thing that I will be honest that would put me in a very good position, and I'm sure members of Council, as you know, presently the plan of the CIC that is the City of North Canton basically centers around industrial revenue bonds and using that vehicle to lend. And I'm sure it's your intention to do both land banking some revenue bonds or whatever is at your disposal that the law will allow you. However, if you could possibly begin over the next couple weeks as this trickles down to a vote to be, to draft some type of language that we would know if you use the CIC as a direct lending vehicle that the people of North Canton, the citizens, whose money will go in there. And I'm not saying that you're well aware of that as well, that we can be somewhat protected. It's very, I know a lot of CICs lend money in very small amounts. Be it ten or fifteen thousand dollars to people that cannot go to ordinary channels to borrow money. I don't think we need that nor is that the type of business that we encourage in our City. But yet there are people for reasons of, of this economic tsunami that we're in that need to borrow money and maybe we can put that in there that would make it very comfortable for me to say, well yea, I think that's a very good idea. No matter who's on it. If I was a citizen, I would feel. And I only, and again I'm not trying to, to throttle you in any way but if you would consider that, I would be appreciative.

Mayor Rice: I have no problem with that. Yea.

Mr. Miller: If I may, you probably need to dust it off because it was passed back in 1980, when it was originally done with the CIC. But there is a plan in effect for the CIC which does allow for both land banking and loaning of money. So it's in the plan already. I can get a copy to each one of the Council members....

Mrs. Herr: It's just like writing a check for any other expenses.

Mr. Lane: Yea, once it's gone then we don't have to, ok. Alright, thank you.

Mr. Snyder: Is there, that brings up a good point. Is there, is there a mechanism that that money can be sent over in the form of a, a subordinated loan to the CIC? Supported by the actual CIC? If, you know, maybe as such as I would go to a bank and borrow money, there could be some codicils put in there because I know members of Council. Some of it through regular general fund. So if there was, but most of the money that came in, cash money year after year, was CDBG funds.

Mr. Foltz: Right. And one way of looking at North Canton has been fortunate not to have to have community development grant money to put into a CIC because we do have money that's been set aside and invested. So I want Council to really be open minded on this. You know, we don't have federal money pouring in here because we need it. Obviously, we're happy to grant, get grant money anytime we can but that's the difference, I think. And we need to really start looking at this. I think the ground work has been done through TAP. Through these economic development committees. Through the Vital and Vibrant Commercial Environment Committee. Through Walsh initiatives. Through community leaders. I, unfortunately, wasn't here two weeks ago because I was ill. But reading through the minutes, everything has, everybody has so many positive things to say, I think it's our responsibility and duty to get this ball started in this group. And I think there's safeguards within the CIC. I mean, the Mayor's obviously on it, two members of Council. And maybe Mayor Rice or Mike Miller is looking at tweaking that to put more qualified people on it. That's fine. There's going to be Council representation here. The Mayor is represented. I mean, I don't think he's going to want to do things that's going to put him in a bad light or the City in a bad light. So I know we want to be cautious with the taxpayers money, but here again, we bought this Arrowhead for the Fairways. We're not seeing a big return on that right now. But we know down the road, there's going to be a big payday for us. Besides from what we saved on additional infrastructure costs for those neighborhoods. I think we need to be proactive here and let's, let's start moving in the right direction. We can't wait 'til the sky falls completely down. We don't know what's going to happen across the street. Tomorrow, let alone two years from now. And if we don't get this in place, I don't think we can afford to wait six more months. I'm also not in favor, I'm going to go on the record now, hiring a consultant. When I seen that presentation, I think all the ground work's been done through these different committees. That presentation didn't tell me anything I didn't know. I think for \$50,000 or better to keep it in the CIC or try to attract some businesses here. So that's my two cents worth. Cause again, as we said, if we're gonna fund this thing and use it, we felt it was a smart move to bring more people into the decision making process when you're trying to anticipate that Council would be concerned about, you know, that money. Who's gonna be responsible for the spending of that. And you certainly want community involvement but I think it's really important, it's imperative that you keep you elected officials involved because we're the only ones that are really held accountable to the public through the ballot. You know, if you put, if people in just, community people do it and spend your two million dollars and waste it away, how do the citizens, you know, respond to that? They can't vote them out of office. So you got to have some accountability with public officials, I believe. So, to do that, that's why we suggested, well let's go from four to eight. It was basically the makeup of the Board of Control, that's what it's been, to expand it. Bring two Council members in to it. So you got Council input from two members there. And then we're going to bring two, two people in from the community.

Mr. Peters: The reason I asked that is, I can't, I was looking through here, I can't remember who said it. But someone mentioned a banker or a real estate professional or...

Mr. Lane: That was Daryl Revoldt.

Mr. Peters: That's right, Daryl Revoldt.

Mr. Lane: He suggested if we're talking about real estate, let's get a realtor...

Mr. Peters: That's right.

Mr. Sarbach: That's my ...inaudible.

People want to live here. If you look back, and no one said this, we've worked very diligently, the Council and the Administration, to put the Sanctuary inside the City. Which is two hundred and five homes. Which brings about \$165,000 in City income tax projected. It could be greater, it could be a little less, along with fees. And on behalf of City Council, I want to thank you all for all your participation and I will assure you that this Council will look at it very diligently and we will cooperate, as best we can, to drive what we can to make this a pleasant place and make you people proud to continue to live here. But I want to thank everybody and I want to thank for all the cooperation, we've been through, all the problems we've been through, it looks like we seem to want to cooperate and I hope that's the case. Saying that, I will want to say Mr. Lane, you did ask me a question relative to McKinely and Pineview. Those will both be on the agenda. I did ask the Engineer to remove them last week due to the fact that we did have two presentations....

Mr. Lane: Oh, I understand that.
