And that, actually, at this point, I don't know I'm not a real student of the health insurance, but I don't think anybody will bid more than a year at this present time.

Mr. Miller: We're, we're going to try to bid more than one year but there's no guarantee that we'll be able to get that. So at this point in time, we haven't put a period on it...

Mr. Lane: Leaves us the option.

Mr. Miller: ...until, because obviously it's got to come back for concurrence of Council at that point in time. When we come back for concurrence, also come back with a period of time that it will be good for.

Mr. Snyder: Right. And as it being self insured, I mean the first year with Aultcare we had tremendous losses to be very honest with you. Really, had we not been committed for the second year, we would have probably been looking elsewhere. Now, through some things the Administration has put in place, the costs have come down to a more acceptable manner. As you know, now the employees are now paying a portion, I believe ten, ten percent they pay. Something like that.

Mrs. Kiesling: And then co-pay.

Mr. Miller: Depends on whether they're in or out of...

Mr. Snyder: They have co-pays, all get put into place through the efforts of the Administration and it has lessened our actual costs. So now we're becoming a little more favored nation, as they would say. So they're a little more willing to talk to us again with three hundred and some heads I think we insure, plus families.

Mr. Snyder: Yea, we get quite a few. So that's the reason on that right now.

And this just basically puts the funding in the right accounts that we need to cover our costs, or the eighty percent costs from the feds for this project. I found out about this at three o'clock this afternoon that they needed this. Essentially, they would like to have it signed tomorrow but we still have to do a Board of Control. Their fiscal year ends at the end of May. So they need all the money in the right accounts by the end of May. So we need to get it signed so they can send it down to central office, get it back and everything will be copasetic. So I appreciate your diligence and speed on this.

Mr. Lane: Inaudible...no questions...

If my memory serves me, and I could be mistaken on my numbers, but we changed the appropriation from South Main increasing it by approximately two hundred and some thousand dollars. 290 if my memory serves me. Mr. Sarbach: The plant, excuse me. Not the raw waterline because we pass that every time we go down the street, but the plant. And it's progressed quite handsomely since this spring so...

Mr. Foltz: Greg, we're alright to do that? I don't want any problems with the press.

Mr. Snyder: We have to invite the press. If we meet, we have to invite the press.

Mr. Foltz: So they're more than welcome to come along and ask questions, look at that. That's fine.

Mr. Snyder: Yea, they're more than welcome to come look at it.

Mr. Foltz: We're not having a meeting. We're just looking at...

Mr. Sarbach: No, we're just, those of you who are interested...

Mr. Foltz: ...just so, you know, everyone's aware of that.

Mr. Sarbach: ...if you want to go as a group, we have to invite the press.

Mr. Foltz: That's fine. Why don't you set something up...

Mr. Sarbach: If you want to go individually, I think you can just make those arrangements and go individually. So whatever your preference is.

Mr. Foltz: When are you thinking about doing that?

Mr. Sarbach: Pardon me?

Mr. Foltz: When do you think we should do that? We don't have a meeting next week, right?

Mr. Sarbach: I would suggest because of everyone's schedule if you just can get a hold of Mike and let him set it up with down there that. I mean, it's not a social event. It's just an informative thing.

Mr. Miller: So we're going to have to take a look at that. Paul and I will talk about that this week.

Mr. Foltz: Could we make it like either six o'clock before a meeting or if we knew we weren't going to have a long meeting, which you never know. You'd want to go when it was still daylight, wouldn't you? So you could see. I'm sure you got adequate lighting there but...

Mr. Miller: There's adequate lighting but it's, it's, you can see the outside and some of the other stuff there.

Mr. Foltz: Yea, you can see everything come together a little easier. How does that grab everybody? Like at six o'clock? Would an hour be sufficient? If not an hour, forty-five minutes. There down the road, it'll take us...
