## Ordinance No. 126-03 - First Reading

Ordinance No. 126-03 authorizing the Mayor of the City of North Canton, through the Board of Control, to enter into contracts for the Water Treatment Plant Expansion project, pending final approval of the Ohio EPA/DEFA, and declaring the same to be an emergency.
