7. Recognition of Visitors

Mr. Snyder: Is there anyone in the audience wishing to speak to the council this evening? If so please step forward, state your name and address for the record.

Terrie Milnes: My name is Terrie Milnes. I live at 301 Mississippi Street SE, Apartment 3W. And I'd like to thank council for taking a moment to hear me. First off, Mr. Held stopped ... today. Thank you so much. He talked to them ... our road is getting finished - thank god. And secondly I come to you with another matter of importance to me and my neighbors. We're not getting our mail and when we do it's our neighbors' mail. For a month - I received on 10/15 a child support check that was dated 9/14; it was held up. I have called the North Canton Post Office. And I'm every time they hear my address they say oh, I'm sorry you're on an unassigned route. My children like to eat everyday, they don't care that's it's an assigned route. My neighbors have called. I called 1-800-ASK USPS, I have called the Cleveland Avenue office and talked with them and they told me it doesn't warrant an investigation. My son had midterms that were sent from North Canton High School, Hoover High, four weeks ago, I have yet to receive those midterm reports. And yet nobody at the North Canton Post Office wants to take responsibility just that it's an unassigned route. Today I was informed that now it's an assigned route. Except the assigned route person that is going to be on my route is working another route. So therefore I still have substitutes on my route, but technically it's an assigned route. My neighbors bring me my mail, I take my neighbors their mail. It's just - it's absolutely - at one point in time my neighbor went down - we have locked boxes cause we're apartment buildings, and you unlock it and pull the panel down and the mailman puts the mail in, she found the keys for the entire postal route still hanging in there. She called the postmaster, 45 minutes later and he finally came up and picked the keys up. I mean it's just so frustrating to us and we don't know who

else to turn to. So my neighbors and myself are now turning to you in the hopes that maybe you could dd something that we cannot. And that's all. Thanks.

Mrs. Magel: Mrs. Milnes...

Mr Snyder: Thank you mam.

Mts. Magel: did you say this was one month? This has been going on for one month?

Mrs. Milnes: This has been going on for roughly a year and a half.

Mrs. Magel: A year and a half.

Mrs. Milnes: Yes. Mrs. Magel: Okay.

Mts. Milnes: My neighbor, who is handicapped, doesn't have - we have like eight steps in front of the building and then a step up in and then the mailboxes are on the inside...

Mrs. Milnes: She's had two hip replacements and knee replacements so they put a mailbox outside for her. And she duct taped, now the slot is this big, she put duct tape down with a note that says please deliver my mail to the outside mailbox outside, so she only has to go up three steps. In July of last year, she wasn't receiving her mail. A friend of her's went up and looked, my child support check that I had to have reissued, which takes roughly 30 days or so, had been sitting in her mailbox for three months. And the North Canton postal system told me well sorry, but at least you got it reissued. I'm not hear to cry to anybody. I'm a single working mom and I'll work hard. But I depend on those child support checks to keep my gas and my electric on. And quite honestly I'm not real happy to say this, because one didn't come, my electric was shut off. But I got it turned back on. Everything's good now, but if you could just do me - anything to help me. Anything, I don't care what it is, a phone call a card, if you know somebody that works for them.

MH Lindower: Have you contacted your state representative on that?

Mrs. Milnes: I didn't know who to contact until I talked to Mr. Held today. And then I was like okay, well I'll come talk to City Council tonight.

Mr. Linodwer: Yea.

Mr. McLaughlin: Inaudible... David, can you call the post office on...

Mr. Held: Yes, we're going to do that.
Mr. McLaughlin: what don't we - why don't you set up a meeting for Friday morning, I'll be there. Because I'm going to find out why too, see if had to do some with the street or not.

And this little old lady answers the door and he said mam, I think I have your mail and she goes it's my husband's pension check, thank you. We didn't know where it was and we needed our medicine. I mean they're not delivering greetings from my Aunt Bea in Florida. They're delivering my life, literally, with my child support checks and my bills and whatever else. And they just take it very very oh I'm sorry I can't think of the word...

Mrs. Magel: Nonchalant ... Mrs. Kiesling: Inaudible...

Mr. Osborne: Cavalierly ... Mrs. Milnes: Yes, nonchalantly. They act like it's...

Mr. Foltz: I think it's...

Mr. Lindower: They want to increase the cost of postage again too.

Mrs. Milnes: Well my son saw the new postal service commercial about if there's a black hole your mail will still be delivered, but not if you're in North Canton. And I suggested to the lady at the post office that perhaps she would want to use direct deposit for her pay checks, because don't trust North Canton to deliver them. Anyway, thank you very much.

MH. Osborne: Mam, I would suggest you start a little bit higher up the pecking order and go straight to Raliph Regula and let them - you know it's a federal agency and you'd get a lot more, I would hope. I've used Mr. Regula for some problems with the Federal Aviation Administration and in two weeks he had it all worked out.

Mrs. Milnes: I'll give him a call tomorrow.

Mr. Held: Yes on Mississippi - first off Terrie thank you for your - for coming up and those nice comments, we appreciate that. And Mississippi is now paved. So that - that's looking really well, that project. And I also ask the residents too - we do appreciate their patience because it has been very trying with all the construction that we've had this year. This is a record amount of construction that we've had in the City of North Canton with waterlines and curb, gutter, sanitary lines that have been replaced and it has been very frustrating. And we're working very hard to make sure that we coordinate the contractors and the city personnel. But a lot of the projects are coming to completion now and we're near the end. But we will be out Mrs. Reider, out to your house tomorrow to see how we can help you.

Mr. McLaughlin: On the same line unfortunately the bags were out on my street for last Friday's pickup and they never picked them up. The whole - Overridge, those bags have been sitting there all weekend long since the rain and everything else like that. They did not - they picked up the plastics, they picked up the garbage, but they never came back for the leaves.
