So it's important to work together with the schools as we have in the past. So by Mr. Gallina, Superintendent, joining the CIC, that ensures really that the city schools will play an active role in our decisions through the CIC. They are - as everybody knows our top three employers are the Hoover Company, the city schools, and Walsh University. So I wanted to make sure we got someone qualified out of those areas that can represent a significant section of our - of our employee - employment base here in the city. So I've talked to Mike, he's agreed to serve, and is looking forward to it.

Mr. Snyder: Good.

Mayor Rice: So those - those will fill my two appointees on the CIC Board.

Mr. Snyder: You know not to step on your foot Mayor. We do have several names I know. And I would think it may be helpful to the issue maybe if council, prior to the election, we appoint our second person - our person actually, one person we have. And possibly, you know over the next day or so, if you have any additional names. I know the majority of you were good enough to send names in and we haven't – that we could do. Unfortunately, our rules don't require - we don't meet next Monday, it's the fifth Monday. But we will be meeting Monday prior to the election and if – possibly we may be able to firm that up. So maybe I'll give each of you a call here in the next couple days and see if you have another name. But I do appreciate that information and we'll – we'll
