#### 7. Recognition of Visitors

Mr. Snyder: Are there any constituents in the audience wishing to speak to the council this evening? If so please step forward, state your name and address for the record.

Larry Taylor: My name is Larry Taylor. I live at 1115 Knoll Street. And I would like to tell you about our problem. I've got to give you just a couple minutes of history. We built the house we live in back in 1976. The sewer was not placed low enough for us to tap in so we have to - we have had a lift station since that time. The lift station needed to be filled with dirt, which we did. We put a railroad tie wall. About the third year in we got a deluge of rain. We happened to get the rain coming from the east down Knoll, coming from the west down Knoll and the south. So ...inaudible... right into our yard. The city was kind enough to come out and put catch basins in three of them, which catches the water and diverts it from our wall and - but it goes down the side and onto our neighbors, back onto our backyard and over to our other neighbors' house. Over this last 20 years I've approached the City Engineer, the administration, councilmen on at different times trying to get something done as far as approving the road to take the water away. I spent six and a half years - my final six and a half years in the service in the Pentagon trying to get money selling programs ... Congress. So I know that money is hard to get and I know it's difficult so I have not really pushed too hard until lately. We have had times when the administrator has said you're first next year - you're going to get it. This was ten years ago. Unfortunately that administrator left. So back in the same ball park again. Before elections I've had people say you're going to get it. Election comes, it disappears. Got to the place when you're going to get it one time and they said, oh, we've got to put a pipe in the street first. We need to dig it up before we do yours. So we said great. Two years later the pipe's in and nothing is done. Now all that we get - you know we have our problems, we've had our floods, but usually around July the water is dissipated. This year is different. This year has now brought it to a crisis level. Three reasons - one, you know the rain we've had. I mean tremendous rain, everyone knows that. That caused a problem. The neighbor in the back brought in fill dirt, filled his area so now the water can't drain normally out to the north like it used to do, so it's all backed up - second big problem. The third big problem, is west virus - West Nile virus, the mosquito problem. Now we've had several out there walking through our mosquito field and it's horrendous. The city was good enough this year to put larva killer in, to come down close and to try to eradicate the - as many mosquitos as they can, but they can't get them all. I even went out and bought a mosquito - one of these new gadgets, 200 bucks worth to try to collect the mosquitos in. Some of them call them mosquito magnets, whatever they are. All them work a little, but not a lot. But something needs to be done and needs to be done badly. Now I've got some - I have some pictures here that I'd like to just pass around to show you our problem. The first two pictures that I'm going to show you is of our backyard. It was taken on the 7th - the 27th of July. The water had gotten within 3 feet of our house in the back and the side. And that's from about 60 feet out. The next picture I'm going to show - the next two pictures are our neighbors' yard. This happens to be Katie Schuster's area and it's always swampy. It lasts almost all year. On our other side the neighbor, I'll show you pictures of how flooded he is. Then what's really bad is after about five days all that vegetation spoils. You wouldn't believe the smell that exists. And then I have two last pictures. These two pictures were taken on Sunday of this week. You'll notice the problem still exists. Inaudible... take three pictures. I took one of all three areas. We have another little problem and that is we've had a housing allotment built above us and we get water from them. Now we fought for three years with the Planning Commission and were successful with the help of the Planning Commission in preventing ten houses with no drainage to a compromise where we have five houses and some drainage. There was an agreement to run all that water off. But once the city approves and walks out, they can do anything they want and they have. They brought the rain water off the spouting down into our area which was - part of the initial agreement was they would go the other way. So that a third thing that - I mean another thing that has complicated the issue somewhat. I'd just like to say, in fact I'd like to beg, for you to do something in an emergency basis to get this program

started. I'm scared to death and the reason is - well two reasons. One is this is an election year. You know same old thing. We need to get it started. But the other is if somebody in my family happens to get West Nile virus, it'd be a tragedy to us and to North Canton. The kids come over - our grandkids come over and play a lot because we got a big back yard - play football, basketball, and so I'm making that plea to the council. Thank you.

Mr. Snyder: Thank you sir. Anyone else in the audience wishing to speak to the council this evening? May I have a motion to a...

Frank Bressi: Thank you. I'm Frank Bressi. I live at 206 Summit Street SW. I have addressed and I have talked with a couple of the council at large, Kathy Magel and Chuck Osborne, about an issue we have in our neighborhood. I just want to bring it to the council's attention. I believe it's your Street and Alley Committee...

Mrs. Magel: Yes.

Mr. Bressi: inaudible... is well aware of the situation. And I would ask Kathy that you would share that letter with other council members. It pretty much states how we feel. This could become a volatile situation in the neighborhood, which we are trying to avoid. I would appreciate it if you would note our concerns, our opposition to the vacation of the section of the alley that is being requested. And if you'll notice by the number of signatures on the paper, there are approximately 11 property owners who are opposed to the one person who would like it vacated. Yes, that letter right there, if you could share it I sure would appreciate it. Thank you.

Mr. Snyder: Thank you sir. Anyone else wishing to speak to the council? Please step forward, state your name and address for the record.

Kim Schaufele: My name is Kim Schaufele. I live at 213 Glenwood Street SW. I'm the one that is petitioning for the vacation of the alley way. The neighbors to my, I think it's the west of me, have all had the alley vacated and they have been, I guess, deeded the property to their sides in both ways. The section of alley that I'm talking about is a 6 foot by 25 foot section of alley. I know there is a number of concerns that my neighbors have had. They haven't brought these forward to me until the other day when Kathy Magel was over. I did ask her over to my house. She did come over and that was really nice of her to take some of her Sunday out to come over and see the alley that I'm talking about. I understand that the neighbors have concerns and I have shared with Kathy and with them that I'm willing to work with them on this. I really have nothing further to say on this at this time other than I know that Kathy Magel has commented that maybe the alley has already been vacated and that this would just be a process of having it deeded into my property then. And she is going to be looking into that. Thank you for your time.

Mr. Snyder: Thank you.

Mrs. Magel: May I make a follow up?

Mr. Snyder: Please.

Mrs. Magel: For both neighbors we agreed that possibly, hopefully, preferably, soon we're going to have a new lawyer and I wanted new lawyer, since I am not a lawyer, to look this situation over. Both of them were in agreement. So I think the situation is I hope not volatile at this time and I'd like a cooler head that is in - knows the law to take a look at the documents that I have and can look at them through a eye of a lawyer. Thank you.

Jan Kotila: I'm Jan Kotila and I live at 208 Summit SW. And I'm next door to the Bressi's and actually share a driveway with them. And I wanted to say in response to Kim's mentioning that we had not told her our concerns before, the reason we have not is because she did not tell us that this was coming before council. She presented a paper for Frank and Harold Fockler's signatures to give her the alley and they explained to her then their concerns about handing over the alley and it involves a big beautiful tree that we're not certain she would not cut down. Since she has removed all the other trees from her property. So they may have, we all may have just sat down and talked about this had Kim not tried to deceive them over bringing it to council without signatures. And actually there was some deception going on on getting the signatures in the first place. And I think that's where the hard feeling began.

#### Ordinance No. 107-03 - Second Reading

Ordinance No. 107-03 amending Land Use Category (d) (5) and (e) (3), (4) and (5) of Section 1137.03 SCHEDULE OF PERMITTED USES of CHAPTER 1137 Business District Regulations of Ordinance No. 50-03, Zoning Ordinance of the City of North Canton, by changing those categories from P - Principal use permitted by right to C - Conditional Use in a General Business-A and General Business-B district.

Mr. Snyder: Chairman Osborne.

Mr. Osborne: Thank you Mr. President. Under our previous zoning code land uses permitted under General Business-B prohibited land uses such as drive throughs, car washes and gas stations. With the recent passage of the latest city's zoning code, this has somehow kind of slipped by council to where they were suddenly permitted uses, which were pretty much were identical to General Business-B. So this is just an attempt to return General Business-A districts to somewhat prior land use situation. The Planning Commission - I guess I should back up - I -I had recommended or urged the Planning Commission to return it a - the previous situation where they would not allow these kind of uses. The Planning Commission recommended making them a conditional use, which is a step in the right direction and provides some protection for the city residents. So that's what we have done. We've already voted the first reading on this and this will attempt to rectify what was I feel an oversight when the new zoning came into place. This will force a desired use of either like a drive through or a car wash, there will have to be a public hearing take place, public input and come before council before any of these uses in a General Business-A allowed. So it provides some additional protection and returns us somewhat back to the prior state of the older zoning code. If anybody has anything to add to that, otherwise that's all I have Mr. President.

Mrs. Magel: I'd just like to say it also would then involve notification of the public also prior to the meeting so they would know what was happening in their neighborhood.

Mr. Osborne: Well that's what I said, there would be public meetings and Planning Commission review. So it returns us to a safer level of protection than just outright approval for these kinds of uses that were previously outlawed in General Business-A. Thank you Mr. President.

We discussed - Director Held was there representing the administration, the three county commissioners were there and truthfully I don't think gave us any real quick guidance. They seemed to say the problem lies with the city. And it was the hydrologist, Mr. Chris Barnes, from the county suggesting that the study needs to be done. However, it's my recollection, Chairman McLaughlin, that prior to spending this 75,000, which I think we should do in ... but I believe the fund has \$220,000.00 in it. I would like to possibly - if it's permitted, to amend this legislation, that study and engineering be done on the Everhard Road culvert. I cannot tell you how strongly the residents of that area, some 265 I believe, live immediately - that their property is in peril to a flood of that Zimber. They tell me, and again I'm only basing - I'm not an engineer, that dredging the ditch, which would take some bureaucracy to get done, is not the immediate answer to the problem. However, relieving the water that does collect at Everhard, can possibly give them some type of relief and I would like to - I would like to recommend that change at this particular time.

It's like a 100 x 80 foot box culvert. And I'd like to see that - the initial design gone ahead and they can fine tune what that crossing is going to cost as well as the one under the railroad tracks. Those are the two biggest bottlenecks in that whole drainage system...

I don't mean to slight the people that the Zimber Ditch affects. You know I went on and on last week, if you remember about the water situation with ..., 77, the parks, the Zimber and the other ditch that we have on the - and the creek on the other side of town. So as long as the parameters that we're doing this through involves the county becoming a partner with us, a major partner, not a 10 percent 90 percent deal where we're funding the entire thing, that is not our responsibility. I believe the culverts are not our responsibility. So the county needs to step up and take care of this for us. To me it's no different than saying we're responsible for the drainage on 77. That's not our responsibility either. So they need to be fair in this process. And if that moves this along I'm all for it, but not for spending any more money than we have to, because they're legally required to do so.

Mr. Snyder: Mr. Foltz...

Mrs. Kiesling: We need to clarify something.

Mr. Snyder: Commissioner Regula's statement and those of you in attendance please correct me cause sometimes I have a tendency to exaggerate a little bit, but his statement was that his father said to him, moving along he would help him hand and glove with probably financing anything that is engineered as the city's share of the project. And relative to the I77, you were right on point, that was brought up by not only the people in the audience, but by the county engineers themselves, of the impact of I77, the widening and ODOT is now studying that for their share. The county does like to hide behind the fact they don't have money. But the administration has told me that you know they'll drive this thing as far as we want them to do it relative to the county's participation. But without an engineered project ready to go, to be very honest with you they just simply said we won't get priority funding from the federal government. And I think the estimate on that culvert, the one along Everhard is...

Mr. Held: One million dollars. Mr. Snyder: 1.5 or something. Mr. Osborne: 1.4, 1.8 I think.

Mr. Held: There's...

Mr. Benekos: The initial estimate, and that was maybe five years ago...

Mr. Snyder: Four to five ... Mr. Benekos: Correct.

Mr. Snyder: So it's going to be probably a million and a half to two million dollar just the one culvert alone. So it's critical that we are in line with our engineering and we're ready to move forward with it that we can get the help of Representative Regula and the County Commissioners.

Mr. McLaughlin: One - oh I'm sorry.

Mrs. Magel: I'd just like to make a comment. We're turning this into - I agree with Rick, this is not the proper procedure. We have just stopped this meeting of a council meeting and made it a council of the whole meeting. We need to have disciplined ourself and if we wanted 220,000, council should of been not told and sprung on like we were just right now. However, I was at that meeting and I do agree ... everything that was said. Councilman Regula said if it's - I think he held up an engineering and he said thee who is ready will get the money. And he told us to get our ducks up - ducks lined up and get those-further investigate those culverts and naturally we want that engineered. But as far as procedure wise, this should not of been sprung on us.

Mr. Osborne: Well I don't think we're springing it on anybody here. We have to be prepared. Just like Mr. Snyder says, we're going to have to get our numbers, crunch the numbers and be up front in line with specifics so the government feels comfortable knowing that the money has been accurately ...

Mrs. Magel: And we ...inaudible...this at a council of the whole meeting ...inaudible... on the agenda.

Mr. Osborne: I'm sorry, may I finish Mrs. Magel? So the government knows that this has been thoroughly studied, they have accurate figures and the budget process can start for us. Even if we start our engineering and make our requests, I'm sure you're looking at least two and a half, three, four years before any funding will come. And the feds or the state or the county, they're not going to pay 90 percent of this, it's a matching and that's what Commissioner Regula said, they will match. And we must show an interest in our own problems or they're not going to care about our problems. So I'd like you - of all the times you have always followed this President of this Council, please follow this gentleman now, because he is right.

Mrs. Kiesling: I agree ...inaudible... I'd just like to say I think you know in the times of need we need to be flexible. And the meeting with the residents was last Wednesday night after our council of the whole. So I have no problem amending the agenda and funding the whole project and if you have to come back for more that's not a problem either. And hopefully we'll get in the - even more money in the budget for next year to do all the culverts. But I also want to clarify Doug - the residents out here were going to say something to you. As far as the county they made it very clear that they are not responsible for the Zimber Ditch. That back in '57 a law was passed that they had - the county had to maintain all ditches,

but only ditches that they built from '57 on. All of these ditches were already dug. So they are not legally responsible to maintain the Zimber Ditch or any of their retention basins that we have in our area. They are willing to help us as a whole as far as with Green and Plain and Jackson and Canton hopefully. But they are not legally responsible to maintain these ditches and I believe that's what they were going to say to you. He made it very clear, he said that that has been a misconception for many years.

Mr. McLaughlin: That's good. You got a memo from me today about Abbeyshire, about the gentleman being out of town and - Okay. And also did we get a letter back from the state on the mines yet on McKinley Avenue?

Mr. Benekos: No we have not.

Mrs. Magel: And Mary Louise, if I may give you a copy of this letter that was from those residents, could

you copy it to all of council then?

Mrs. Bittle: I certainly will.

And perhaps we could take the 50,000 from the community sign and do some study over there or something.

Mrs. Magel: I thought we already did something with that.

Mr. Osborne: Also I guess I would be disappointed if I didn't dumped on here. Mr. Treadon, you didn't disappoint me tonight. I appreciate your legal opinion regarding Mrs. Magel's comments. This council does need to be responsive. We do have procedures, but we can accelerate those procedures, we can make them work for the public. And I appreciate your legal opinion on that. I don't appreciate your personal comments. I don't believe the Law Department should be espousing their personal opinions up here. It just continues to add to the fire and encourage everybody else to continue the same. And to the press I'm not the lightening rod for that tonight. I was trying to explain my position. As I said clearly both law - attorneys were quite competent. I don't know why I have to be berated because I saw in Judge Lillie some outstanding credentials, just as I saw in Mr. Pusateri. Why I have to be beat up every time I defer from somebody up here I don't know. This council does not have to vote unanimous on everything up here. I was simply trying to recognize that there was another qualified individual. And it's just too bad there's no room for debate, no room for differences up here on this council. Thank you.

Mr. Snyder: Thank you. A couple things. I don't - isn't next week the open house for the Fire? Mayor Rice: The  $6^{th}$  and the  $8^{th}$ , yea.

Mr. Snyder: The 6th and the 8th of that next week if you get some time stop there either before or after council. A couple things I'd like to say. Number one, from the chair, I'd also like to thank Mr. Lindower and his committee for a job well done. That was an awesome thing getting through that but I think you did a great job. Again, I appreciate all three of you doing that. And my apologizes to my fellow members of the council, Mr. McLaughlin as the chairman. After that meeting I know you had some ...inaudible... with your constituents, I was with mine and I did not have any additional conversation with the administration as ... relative to that. But if I put you in an awkward position, my apologizes sir. But at the same time, thank each and every one of you for your support on that. It's very important to me and I do appreciate it. Mr. McLaughlin, relative to your - request did come from administration to engineer and to proceed with the project at Knoll and I believe it's Northfield. Is that correct? To my request it was removed as it is under and I'm not trying to be smart when I tell sir that if you could bear with the budget the Mayor comes within the next couple of weeks. The problem being that the project in itself even broken up is about 2.4 million dollars. The engineering I think is about 105 thousand dollars. If you sir would be - at that point I'm sure it will come in and at that time can be duly discovered. It's a terrible situation and I know I'm speaking out of both sides of my mouth when I tell you this, but to begin to use future budgets for projects that we don't know yet what the budget is, is not really fiscally the best way to do things. And we also have committed to a project in Ward 1 already for approximately 150 thousand dollars. We normally to start we have about three and a half million dollars. And we're committed to another project and I know in the 4th Ward and couple other jobs that are very high priority. But I will promise you sir that your view will be given very very good consideration. Mr. McLaughlin: Thank you.

Mr. Snyder: And when you return that list I'm sure that will be number one priority, but we will address that. And if you could be patient and wait a couple more weeks till that budget begins to materialize, at that time we will gladly look at it. I'm saying we as the administration then will look at it from our side. So I was the one that stopped it sir and I didn't - as I talked to you on the phone, I didn't want you to think there was anything intended by it. I talked to Mr. Taylor ... the same way. But we will address that. Mr. McLaughlin: Okay.

Mr. Snyder: I do appreciate...

Mr. Osborne: Mr. McLaughlin or Mr. Snyder...

Mr. Snyder: Yes sir.

Mr. Osborne: can I say one other comment?

Mr. Snyder: Please.

Mr. Snyder: Well your comments are well taken. Thank you.

Mr. Snyder: Is there any other - anybody in the audience wishing to speak? Final call for the - to the council. Anyone ...inaudible... have any comment? You're more than welcome to step up and say something. Sir, step forward, state your name and address for the record.

Ken Schilstra: 601 Linwood. And I want to thank all of you for the Zimber Ditch issue. It's not a new issue. The '97 study said that this issue had existed for another 5 to 10 years before that. So - but don't forget the people on the Nimishillen. You know that's important too, because those guys are in the same boat. But in the last two weeks we've had rain, two different occasions, none of which was very heavy, the creek crested at the top of the banks. If you call that flood stage, flood stage was a normal rain fall ...inaudible... Not a 25 year surge for flood, not a 100 year, a regular. That's why it's important. Thank you.

Mrs. Magel: Sir, I would like to thank you for your comment about the Nimishillen. Inaudible...

Mr. Schilstra: Yea we - don't forget those guys.

Mr. McLaughlin: Thanks. Appreciate that.

Mr. Schilstra: No that's you know...

Mr. McLaughlin: The one thing I think we ought to do as a council and pass it on to Mr. Benekos, when we have these developments we look at - if there are retention basins we look at those retention basins being a 25 year or whatever. We ought to change that. I mean we ought to look at that more of a 50 or whatever because some of those retention basins in those new allotments or developments just aren't adequate for some of this. I mean I know we don't get it all the time, but it needs to hold the water a little bit longer or whatever in through there. I think that was one of the things we discussed last week, with all this asphalt and cement that has come down the last couple years, that we need to look at those retention basins.

Mr. Schilstra: If you design for the 100 year flood now, that means in another 10 or 15 years it will get 25 year the fall rates because we're going to continue to put more hard surface up. So it's not going to go away, it will only get bigger. So and maybe the Law Director needs to take a look at what leverage we have of you know development outside of the city. Because they're dumping the water down in our neighborhoods. We aren't generating it. The City of North Canton is built. In the same way maybe there is someway we can squeeze money out of the county. If that's - we've got a job for you. Thank you.

Mr. McLaughlin: Boy tonight we've had about 10 new programs for the new Law Director to start and he hasn't started working yet.

Mary Schilstra: 601 Linwood. I had an eye opener this week. I've been driving. I spoke to John Meyers I believe, the Lake Township Trustee. He told me where Zimber Ditch started. I used to live up in Greentown. Of course he told me, oh you know you used to live on top of an old mine. I'm like thanks. You go from one problem to the next. My son has piano up in Uniontown and they were skating on Saturday, so Saturday and today I'm driving around. We had 2 inches on Friday so of course Saturday everything's flooded. It's amazing how much water is up there. And today I went north of our piano teacher and into Green, it's right on that border, and I know there's a Lake Township park, I know there's a pond there behind my piano teacher's house there's a couple ponds. You know where I'm all talking about, if you go into Green. I'm like all these housing developments, I don't see any retention ponds. I don't know where this water is going. Oh I know - I'm sorry I don't know the name of the street, but I can find it on a map, but I found one creek going south, I find the next creek going north, a quarter of a mile difference in them. Why is one going south? Why is one going north? The Tusc river is just a stone's throw. It somehow must be ...inaudible..., but I'm just looking at all these streams. Like you're saying we have little feeders and it's just - they all have to be taken care of. You can't take ...inaudible... care of another. And Mr. Snyder, I know you sent out a letter last time ...inaudible... for our neighbors so they don't keep throwing their garbage down ...inaudible... I was out the other day looking for something ...inaudible... and she said she walked over at Glenwood there's a culvert ...inaudible... on the north side ...inaudible... under the culvert.
