7. Recognition of Visitors

Chuck Osborne: My name's Chuck Osborne 307 Fairview Street SE North Canton, Ohio. Approximately two weeks ago, I received a phone call from a city resident who asked me why the City of North Canton was expending public dollars to pave a private drive, specifically Pacific Avenue, SE. The city resident proceeded to tell me that he had asked this same question of city officials in 1993 when this private drive was previously paved by the city. The response this resident was given in 1993 for the paving of a private drive using public funds was that the city had goofed. A few weeks ago as the resident observed the paving of Pacific Avenue, SE for the second time; he asked me if this was another "goof" on the part of the city. The resident who called me owns a lot on the undeveloped portion of Pacific Avenue. Yes, a significant portion of this street is not built even though city maps show this as a through street. A visit to Pacific Avenue, SE would prompt anyone to question the validity of Pacific's designation as a dedicated street.

A conversation with a resident on the north end of Pacific Avenue, on the corner of Knoll revealed that he too knew Pacific Avenue was not a dedicated city street. My question is this, Why do city residents know more about the status of this private drive than city officials? My research at the Stark County map office as well as records on file at the North Canton City Council office show that efforts to dedicate Pacific Avenue in 1993 fizzled out. Efforts to dedicate Pacific Avenue died for a reason and that is quite apparent with a visit to this secluded private drive. It obviously could not be justified. The private drive is not wide enough to meet the city's subdivision regulations for a residential street. This was clear to city officials in 1993, as the historical documents clearly spell out. This should ring loud and clear today as well. It is the same secluded private drive. I would like to know why the Ward 3 Councilman put this private drive on the city's paving list. As I stated earlier, a quick visit to Pacific Avenue should raise red flags on the validity of Pacific's designation as a city street. Where was the North Canton Engineering Department in this? Where was the City Administrator? Where was the mayor? Did anyone really care? Does the fact that there is an election in a few months figure into this equation for the ward councilman and the administration? It is admirable that the Ward 3 Councilman can get things done for his constituents, but one must operate within the bounds of the law. And just as important, one must do what is fair for residents throughout the City of North Canton. Not just what you can get away with in your ward when you are in good graces of the administration. I was appalled last week that anyone on this council or any city official would consider a change in the status of Pacific Avenue from a private drive to a public street or even an alley. Changing the status of Pacific Avenue to a designated city street or alley is a major shift in policy. And is simply not fair to residents who live on streets that present much less financial liability to the city and are much more deserving of city services, and yet receive nothing for the taxes they pay to the City of North Canton. I have seen several situations throughout the city where residents living on streets that substantially meet requirements for a city street and are much more deserving of city services, but were turned down when they requested snow removal services. One such street, Sherbrook Circle comes to mind. It was built in the early 1990s and serves 36 condos, home to mostly older citizens. Sherbrook Circle has a street width of over 29 feet that's (inside curb to inside curb). This is five feet wider than the street I live on. My street, with a width of slightly over 24 feet (inside curb to inside curb) enjoys street maintenance and snow removal. Sherbrook Circle, at over 29 feet, and built to meet city codes is denied street maintenance and snow removal. Pacific Avenue only has a right of way of twenty feet. The most recent paving of asphalt is a fifteen foot wide band of asphalt which is about all this secluded private road can accommodate. Pacific Avenue in no stretch of anyone's imagination comes close to meeting the requirements of a city street. Is any of this fair? The paving of Pacific Avenue was a violation of state law because taxpayer monies were used to maintain private property. But more importantly, if was unfair to other city residents. To now change the legal status of Pacific Avenue to a street or an alley to cover up years of unlawful preferential treatment will leave the city with no choice but to provide similar treatment and services for other residents throughout the city who live on undedicated roadways. Compliance with Ohio State Statutes ensures that taxpayer funds are spent fairly, and that taxpayers are treated fairly. The expenditure of public monies must comply with the laws of Ohio. The distribution of city services must be consistent and fair to all the residents of the City of North Canton. Thank

FINAL CALL FOR NEW BUSINESS:

Mr. Snyder: Is there a final call for business? Anybody wishing to speak to the Council... Sir?

Craig Monastra: Craig Monastra, 185 Creekside Circle NE, North Canton. Basically I just wanted to mention a few things. I have a major concern with the traffic that is currently on Marquardt Street, which is on my back yard. As most of you probably know it's a 25mph speed limit. No stop signs throughout that whole north – south run and you come down Plain Township heading south, you go from 35 to 25, right at Seventh Street. And typically no one stops. I have sought help from the Administration, Mr. Miller. And he's actually done helped-helped the situation. Added more police patrols, added one sign warning that the reduction of the speed limit's 25. And also the temporary radar has been placed out there. I think four or five times, but unfortunately the patrols- they can't stay there seven days a week, twenty four hours a day. And unfortunately, no one seems to want to obey that speed limit. That's why I had a concern with the permanent vacating of Weber and Briar. Because more traffic will be added to that north- south run. So I request that someone- the Council look into doing maybe a traffic study, or some type of solution to permanently fix, or at least try to correct the problem of the speeding that's on that 25 mile an hour street. I know that you're talking about putting a walking trail or an entrance right there at 7th Street and Marquardt. But if you do that, than basically you're creating a hazardous situation with all the speeders in that area. So basically I just request that something be done to control that traffic before someone gets hurt. Or the property values and everything else start falling. Thank you.

Mr. Snyder: Mr. Monastra, have you contacted Chief Grimes in regards to a traffic survey?

Mr. Monastra: Well I talked to him about stop signs and other recommendations. It was the same time I talked to you in May actually. I talked to Mr. Grimes- Chief Grimes and he actually put the temporary radar sign out there the very first time. And then I started dealing with Mr. Miller and he's been very helpful as I said. I actually met him in person the first time that they...

Mr. Lindower: What I had in - what I had in mind on that, is you're talking about a temporary radar unit. That speed monitoring radar awareness trailer that they use out there. It's got the capability of not only recording not only the traffic count, but the average speed as well as the time of day that- that speed is the highest.

Mr. Lindower: And that's what I say if you want to go over that with Chief Grimes maybe he can give you some idea... or if you have a particular problem at a certain time of the day or afternoon- if you advise him on that too. Generally what we tried to do is, do a 24 hour survey on that. Leave that unit there for 24 hours. That way we have the peak traffic count during the week, or even on a weekend. Which ever happens to be the heaviest.

Mr. Miller: We- we did something else, hopefully it doesn't appear in the newspaper. But we had it out there for about three or four days that it appeared to be turned off. It wasn't showing people what their speed was, but it was recording their speed. So we have those figures as well.

Mr. Lindower: It has the capability of doing that. And there's nothing wrong with doing that because it isn't used for enforcement. So there's no problem with it.

Mr. Monastra: Well unfortunately, when the city just repaired the south side of Marquardt and paved it- and you warned me this would happen. People now have a faster approach getting to my house. Coming from where the churches are - I mean the streets wide and really it's just a non stop cut through. And unfortunately there's not many streets that go north and south in the city. I mean everything seems to be dead ending these days. So I...

Mr. Lindower: That would hold the detours that we've got set up around town.

Mr. Monastra: Well I don't know, maybe you can vacate my street. Or something along those lines for the good of the cause. Basically I just request that something be looked at before it gets to serious. Two weeks ago, Mr. Snyder made a comment that possibly an interest in the sanctuary would be added to Marquardt. But you know that'll make it ten times worse. So and I know they've been writing a lot of tickets out there. And actually through August 7th you surpassed or equaled all of 2004 with tickets so...

Mr. Miller: I'll have to check. But I think you're probably right...

Mr. Monastra: I got the letter.

Mr. Miller: And today we were out there looking at a drainage problem. And when we came in from Plain Township into the city we actually got to follow a police cruiser that was parked at 7th Street and turned south onto Marquardt. So they're still out there.

Mr. Monastra: Right, well and people don't even stop for the cruisers half of the time. I sit there and I watch, people fly by and I mean it's ridiculous. And my concern is the school bus picks up both of my children- two different times there. And day three had someone running the red. So I actually saw Mr. Miller in his office that day because I was so mad about that. And like I said, the administration's been helping but something needs to be done to slow and curtail that traffic. Thank you.

Mr. Peters: Craig if I may, you don't have to stand up there. I just want to as Michael. Once that walking path is through there, I know we can't put a stop sign up just to slow traffic down. But once the walking path is going through there, would we have legitimate cause to put a stop sign there? Especially since they're driving up to 25mph?

Mr. Miller: That's something we'll have to look at as we design that. And one of the things we've talked about is actually trying to get it under the road as opposed to above the road. And widen out that- that culvert. Because that culvert is in a condition where probably in the next four or five years it's going to have to be replaced. So if we go back with a boxed culvert that's wide enough, we may be able to get the pedestrian traffic under ... (inaudible)... Yea, we'll look at all the options that we have. But obviously we got to follow the Ohio Manual of Uniform Traffic Control Devices in putting up traffic control. Otherwise we put the city in a liability situation.
